NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Rajesh Kumar, Chief Manager-cum-Branch Head, Canara Bank, Bhogal Branch, New Delhi regarding harassment and caste based abuse.

Shri Rajesh Kumar, Chief Manager-cum-Branch Head, Canara Bank, Bhogal Branch, New Delhi, vide his representation dated 23.06.2025, has stated that he belongs to the Gond (ST) community and has been serving in Canara Bank since 1994 with 30 years of unblemished service. After being transferred from Mumbai to Delhi on medical grounds for treatment of his son and disabled daughter, he has been subjected to targeted humiliation and harassment by Mr. Sanjeet Kumar, DGM & Regional Head, South Delhi Region. He has alleged that the DGM frequently uses abusive and threatening language during review meetings, calls late evening meetings without notice, and makes derogatory remarks such as threatening to deny leave, stop perks, post him under junior staff, transfer him to a remote area, or recommend suspension and compulsory retirement. He further mentioned that on 20.05.2025, the DGM misbehaved with him over the phone and again humiliated him publicly during the circle review meeting on 21.06.2025. The petitioner has requested the Commission to obtain meeting records, investigate the matter, and initiate an inquiry into the alleged harassment and atrocities faced by him.

- 2. NCST vide notice dated 07.07.2025 sought facts and comments from the General Manager (HR), Canara Bank within 30 days. The General Manager, Canara Bank, Bangaluru vide letter number HR & PRW:PM:RES:NCST:8462:2025 dated 08.08.2025 has informed that upon examining the matter, no instance of caste-based discrimination was found. The reply was not satisfactory; hence, NCST has decided to discuss the issue with the authority and the petitioner on 11.11.2025. Accordingly, a Sitting Notice was sent on 04.11.2025.
- 5. In the sitting, the General Manager (HR) alongwith other officers of Canara Bank, Bangaluru were present. The petitioner was also present. The petitioner has reiterated his earlier submission and requested for justice. The officials of Canara Bank denied all allegations of harassment. However, when it was inquired that if any committee had been constituted for examining the issue, the officials informed that the committee has not been constituted. The Commission strongly repudiated this evasive conduct. The harassment of an ST Officer of such senior rank in a reputed institution is unacceptable. Furthermore, the absence of any proper investigation into the matter reflects a grossly lackadaisical attitude on the part of the management.
- 7. After hearing both the sides, the Commission recommends the following and action taken report may be submitted in 30 days from receipt of the minutes—
 - The bank management is advised to constitute a committee for examining/investigating the issue. In the committee an ST Member may also be nominated.

The accused officer may be immediately removed from the direct control and command of the
petitioner to ensure a fair and non-hostile working environment.
