Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri S. Bhaskara Rao, Sub Treasury Officer, District Treasury, Srikakulam Andhra Pradesh regarding denial of promotion to the petitioner.

Shri S. Bhaskara Rao, Sub Treasury Officer, District Treasury, Srikakulam Andhra Pradesh belonging to ST category has submitted representation in 20.08.2021 alleging that he has been not considered for promotion to the Post Assistant Treasury Officer despite being fully eligible and already issuing promotion to his Juniors with consequential benefits. He submitted that he had joined in Treasury Office, Srikakulam on 14.07.1999. Thereafter, he got promoted in the next grade in the year 2006, whereas his junior got promotion in the year 2003. Then, he had requested for promotion to the Post of Assistant Treasury Officer as his Junior Shri S. Venugopala Rao was promoted in the year 2020. But his promotion has not been considered so far.

- In this matter sittings were convened on 09.12.2024 and 6.5.2025. 2. In the last sitting held on 6.5.2025, following recommendations were made and minutes were sent to all concerned on 17.6.2025:-
 - The D/ o Finance, Govt. of Andhra Pradesh may consider the proposal submitted by Treasuries and Account Department in the present case on priority basis.
 - The Travel Allowance and Special Leave may be reimbursed / granted in favor of the petitioner for attending the sitting on 09.12.2024 and 6.5.2025 at NCST, New Delhi, as per his entitlement.
- There was no Action taken report received from the concerned authorities. Hence, NCST has decided to discuss the issue with the concerned authorities and petitioner on 16.10.2025 at 12:00 (Noon). Accordingly, summons was issued on 9.10.2025 to Principal Secretary, Finance Department, Govt. of Andhra Pradesh and the Director, Treasuries and Accounts Department, Govt. of Andhra Pradesh for attending the sitting on 16.10.2025.
- The Principal Secretary, Finance Department, Govt. of Andhra Pradesh vide letter no. FIN01-HODS0ADTA(EMNG)/38/2020-ADMN-1 dated 15.10.2025 has sought exemption and deputed Spl. Secretary, Finance Department, Govt. of Andhra Pradesh to attend the sitting.

In the sitting, the above officer from Finance Department, Govt. of Andhra Pradesh, the Director, Treasuries and Accounts Department, Govt. of

Andhra Pradesh and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The Spl. Secretary, Finance Department has provided copy the of letter HODS0ADTA(EMNG)/38/2020-ADMN-1 dated 15.10.2025 of Principal Secretary, Finance Department, Govt. of Andhra Pradesh. In the letter, the chronological events of the case and action taken by the Department in this matter was described. It was also informed that the matter is under examination and appropriate decision will be taken in due consultation with the Nodal Departments (Services and Law Departments) of the State. The Director ,Treasuries and Accounts Department, Govt. of Andhra Pradesh vide letter no. FIN02-11033/41/2021-A SEC-DTA dated 15.10.2025 has communicated that action will be taken by the Department after receipt of the orders from the Government as mentioned by the Finance Department in the letter.

- 6. After discussion with the above officers of State Government and petitioner, the following recommendations were made and action taken there on may be submitted within 30 days from receipt of the minutes.
 - The Finance Department and Treasuries Department may expedite
 the issue with the appropriate administrative Departments as
 indicated in its letter and ensure compliance with the earlier
 recommendations of NCST in 30 days as it already got inordinately
 delayed.

 The TA and Spl. Leave may be reimbursed / granted in favor of the petitioner, as per his entitlement and rules.
