Minutes of the Sitting held under the Chairmanship of Dr. Asha Lakra, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Rakesh Kumar Jeff, National President, and Shri Rajeev Meena, National General Secretary, AISCTREA Sangharsh Samiti, New Delhi regarding regarding the issue of representation of Scheduled Tribe employees in the elected executive body of AISCTREA (All India SC/ST Railway Employees Association) in Indian.



The representation dated 06.01.2025 from Shri Rakesh Kumar Jeff, National President, and Shri Rajeev Meena, National General Secretary, AISCTREA Sangharsh Samiti, New Delhi, was received, highlighting the lack of Scheduled Tribe representation in the elected executive body of AISCTREA. The petitioners requested the Commission to ensure adequate representation of Scheduled Tribe employees in AISCTREA as per its bye-laws and to issue suitable directions to the Railway Board to enforce democratic and inclusive functioning of the Association.

- 2. In this matter, the Commission issued a notice dated 28.03.2025 to the Chairman, Railway Board, directing submission of a report within 15 days. The report was received from the concerned authorities vide letter dated 11.04.2025 from the Executive Director (Estt.), Railway Board, and the same was forwarded to the petitioner for information. Considering the seriousness of the matter and the persistent requests of the petitioner, the Commission decided to hold a hearing with the concerned officials, and accordingly, sitting notices were issued to all relevant parties.
- 3. In the hearing, the Additional Member, Executive Director, and other officials of the Railway Board appeared on behalf of the Chairman, Railway Board, and the matter was discussed in detail.
- 4. The Commission noted the parallel and relevant precedent in File No. NCST/SER-1604/MRLY/2/2024-SSW (Case of Shri D. Nataraju, All India ST Railway Employees Welfare Association), wherein the Commission, after detailed deliberations and repeated sittings (10.02.2025, 17.06.2025, 08.09.2025 & 27.10.2025), recommended that:

"The Railway Board may issue guidelines/advisory to recognise a separate All India ST Employees Welfare Association in Railways, ensuring equitable representation of ST employees, in line with precedents set by other public sector undertakings and as supported by the Ministry of Tribal Affairs and DoPT discussions."

5. After hearing both sides and examining the records, the Commission recommends the following:



As per the hearing held in the above-mentioned file number, the Railway Board is advised to take appropriate action in the matter in accordance with the recommendations contained in the previously issued minutes. A copy of the said minutes is enclosed with these proceedings for reference and further necessary action.

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri D. Nataraju, General Secretary, All India Scheduled Tribe Railway Employees Welfare Association regarding recognition of separate association for ST employees of Indian Railways.

Shri D. Nataraju, General Secretary, All India Scheduled Tribe Railway Employees Welfare Association (Registered Office at Chennai) Sullerupetta (Andhra Pradesh) vide his representation dated 10.6.2024 has stated that a separate recognition should be granted to the All India Scheduled Tribe Railway Employees Welfare Association (Regd. No. 31/2006), distinct from the existing All India SC/ST Railway Employees Association. He contends that various governmental bodies, including the Ministry of Tribal Affairs, the National Commission for Scheduled Tribes, and the Ministry of Social Justice, have recommended such recognition. The petitioner highlights that separate ministries and commissions exist for Scheduled Castes and Scheduled Tribes, and their cultural and socio-economic issues significantly differ. Despite persistent efforts since 2006, the association has not been accorded due recognition. Given the existence of distinct associations for OBCs and SCs in the railway sector, the petitioner argues that Scheduled Tribe employees, numbering approximately one lakh, should also be granted an independent platform to address their concerns effectively. Furthermore, he emphasizes that granting this recognition would not disrupt the administrative or financial structure of the Railways. Citing precedents from Port Trust, Neyveli Lignite Corporation and Chennai Petrochemical Ltd., where separate ST associations have been recognized, the petitioner urges immediate approval to safeguard the welfare and rights of ST Railway employees.

- 2. In the matter, sittings were convened on 10.2.2025, 17.6.2025 and 08.09.2025. In the last sitting held on 8.9.2025, the following recommendations were made and minutes were circulated on 23.9.2025 for submitting the action taken report within 15 days from receipt of the Minutes.
 - The Railway Board may consider to recognise a separate ST Welfare Employees Association in Railways and issue the advisory/ circular to all concerned. If, the Railway Board does not consider the issue, the Chairman and CEO of Railway Board may attend the next scheduled date of hearing with clear justification for opposing the said proposal.
 - An ST Specific Grievance cell may be established at Board, Zonal levels preferably headed by ST Liaison officers.
 - Independent representation of STs in Reservation monitoring cells may be ensured.
 - The TA and Special Leave may be reimbursed / granted in favor of petitioners who attended the sitting, as per rules.
- 3. The action taken report was not received and petitioner has also visited NCST and requested for recognition of All India ST Employees Welfare Association, hence, NCST has decided to discuss the issue with the authority and the petitioner on 27.10.2025. Accordingly, a Sitting Notice was sent on 17.10.2025.
- 4. In the sitting, the Secretary, Addl. Member Staff and other Sr. officer of Railway Board were present. The petitioners were also present. The petitioners reiterated their submission and stated that after recommendations of NCST in various sittings, the Railway Board has not issued guidelines for recognition of All India ST Employees Welfare Association. The officers of Railway Board has reiterated their submission vide OM No. 2021-E(SCT)I/22/16 (eoffice no. 3372442) dated 21.10.2025. It was also stated that the present SC/ST Association is sufficient and setting up / recognition of separate body for ST Employees Welfare Association would involve extensive administrative modification. The petitioners however, strongly apposed and demanded for formation of separate ST Employees Welfare Association.

- 5. The joint bodies like the All India SC/ST Railway Employees Association, the Scheduled Castes members heavily outnumber those from the Scheduled Tribes, leading to continued dilution of ST representation which is deeply concerned. The ST members rarely occupy top leadership roles such as President or General Secretary in the ST Employees Welfare Associations and that their unique cultural, socio-economic and service-related issues are frequently overlooked or minimized. Despite repeated appeals over the years, recognition for an separate ST Employees Welfare Association has not been recognised. Following long-standing efforts by ST groups and the NCST, the Department of Financial Services (DFS) issued a circular in April 2025 permitting all Banks and insurances and financial institutions to create and acknowledge separate ST associations. In light of this, the Commission considers that the Indian Railways, being among the largest public sector employers, should similarly grant recognition to the All India ST Railway Employees Welfare Association to secure equitable and adequate representation for ST employees.
- 6. It is mentioned that the Government of India is well-wisher of the STs. Accordingly, in October 1999 had setup a separate Ministry for Scheduled Tribes i.e. Ministry of Tribal Affairs(carved out of Ministry of Social Justice and Empowerment). Thereafter. in vear 2004 under Article 338A setup a separate National Commission for Scheduled Tribes (by bifurcation of National Commission Scheduled Castes and Scheduled Tribes) and various organizations/schemes have been separated for welfare advancement of Scheduled Tribes. Therefore, the demand of petitioners are justified as the employment privileges ST employees in the Railway of stands on different footing vis-avis other class of employees.
- 7. In the sitting, the officers of Railway Board had stated that the opinion of DoPT requires for framing the guidelines regarding recognition of separate All India ST Employees Welfare Association. In this context, it is stated that Shri Antar Singh Arya, Hon'ble Chairperson, NCST had a meeting with the officers of DoPT on 17.9.2025 at NCST for setting / recognition of separate ST Employees Associations. In the meeting, the reference was made to Para 5(f) of notification no. 2/10/80-JCA dated 5.11.1993 of DoPT, which prohibits formation of service Association on caste / tribe / religious basis. However, NCST observed that the over 730 Scheduled Tribes recognised under Article 342 of the Constitution and they may be considered as one community, similar to OBCs, and hence a separate Association for ST employees may be formed to take up their collective concerns. DoPT was requested to examine the matter and issue necessary directions. The DoPT has been requested to examine the matter and issue necessary directions. Minutes have been circulated vide NCST letter no. 12035/1/2025 Coord. dated 22.9.2025.
- 8. After discussion with the officers of Railway Board and petitioners, the following recommendations were made and ATR may be submitted within 15 days from the receipt of the minutes.
 - The Railway Board may issue guidelines/ advisory to recognise a separate All India ST Employees Welfare Association in Railways Department.
 - The petitioners are advised that in the sittings of NCST in relation to this case only 3 or 4 representatives may attend for the subsequent hearings if any.
 - The TA and Special Leave may be reimbursed / granted in favor of petitioners, who attended the sitting, as per rules.
