

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri K. Raju Nayak, Telugu School Assistant at Zilla Parishad High School (Boys), Banaganapalli regarding suspension due to political pressure.

Shri K. Raju Nayak, School Assistant, Telugu at Zilla Parishad High School (Boys), Banaganapalli vide representation dated 20.2.2025 has alleged that he was suspended due to political pressure despite no inquiry being conducted and though the former Kurnool District Education Officer revoked his suspension and issued reinstatement orders via e-Office on 23.11.2024. The Nandyal District Education Officer, Shri P. Janardhan Reddy, refused to act on them citing political pressure. The petitioner further alleges mental and financial harassment, non-payment of suspension allowance and caste-based discrimination, including being insulted for belonging to the ST Sugali community. He has requested for justice.

2. NCST vide notice dated 03.03.2025 sought facts and comments from the Collector and DM, Nandyal and the District Education Officer, Nandyal within 30 days from receipt of the Notice. The reply was not received, hence NCST decided to discuss the issue with the authorities and the petitioner on 06.05.2025. Accordingly, a sitting notice was sent on 25.04.2025.

3. In the sitting, the District Tribal Welfare Officer, Nandyal was present on behalf of Collector and DM, Nandyal and the District Educational Officer, Nandyal. The petitioner was also present. The petitioner reiterated his earlier submission and requested for justice and action against the officers who were involved in the matter. The District Tribal Welfare Officer, Nandyal has given the letter no. 1997/A2/2024 dated 2.5.2025 of District Educational Officer, Nandyal which contains the facts and action taken by the Department. In the letter it has been mentioned that the petitioner has been revoked from suspension and joined his duties as School Assistant (Telugu) at new place i.e. Uppalapadu Village, Orvakal Mandal, Kurnool District.

4. After discussion with the District Tribal Welfare Officer, Nandyal, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the minutes.



- The DEO may attend to the next scheduled date of hearing with a detailed enquiry report and the reasons for delay in implementation of orders even after revoking of the suspension.
- Any pending allowances due of the period during suspension may be immediately cleared as per norms.
- The Travel Allowance and Special Leave may be granted / reimbursed in favour of the petitioner by the District Educational Officer, Nandyal as per his entitlement.
