Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Dr. Ravi Gugulothu, Assistant Professor (Contract) in the Department of Mechanical Engineering at JNTUH University College of Engineering, Science and Technology, Hyderabad regarding non issuance of no objection certificate.

Dr. Ravi Gugulothu, Assistant Professor (Contract) in the Department of Mechanical Engineering at JNTUH University College of Engineering, Science and Technology, Hyderabad, vide letter dated 11.02.2025 has informed that he has been serving at the institute since 02.07.2011. He has stated that various Institutes of National Importance such as IITs, NITs, and Central Universities have issued notifications for faculty positions under a special recruitment drive for SC/ST/Women candidates, for which a service certificate and No Objection Certificate (NOC) from the current employer are mandatory. However, despite repeated requests, the concerned authorities are allegedly refusing to issue the required documents. Hence, do the justice.

- 2. NCST vide notice dated 14.02.2025 sought facts and comments from the the Registrar, JNTUH University of Engineering, Science and Technology, Hyderabad Telangana within 30 days from receipt of the Notice.
- 3. The Registrar, JNTU Hyderabad vide letter no. C1/AA/2021-25 dated 07.03.2025 has informed that Dr. Ravi Gugulothu is working as an Assistant Professor (Contract) in the Department of Mechanical Engineering at JNTUH University College of Engineering, Science and Technology, Hyderabad, on a yearly contractual basis from July to June for a duration of 11 months and 29 days with a one-day break. It has been stated that as per JNTUH norms, Service Certificates and No Objection Certificates are issued only to regular faculty. Hence, Dr.Gugulothu has been issued only "Contractual Working Certificates" multiple times on his request. The University maintains that there is no discrepancy in the matter and that the college is acting in accordance with established norms. This was forwarded to the petitioner for information on 04.04.2025.
- 4. Dr. Ravi Gugulothu, vide his rejoinder dated 16.04.2025 has refuted the facts and requested for justice, hence, NCST decided to discuss the issue with the authority and the petitioner on 06.05.2025. Accordingly, a sitting notice was sent on 21.04.2025.
- 5. In the sitting, the Registrar, JNTU and Principal, UCEST, JNTU, Hyderabad were present. The petitioner was also present. The petitioner reiterated his earlier submission and requested for justice. The Principal, UCEST, JNTU, Hyderabad has provided the letter dated 2.5.2025 which contains the details in respect of NOC and Certificate issued to the petitioner.
- 6. After discussion with the Registrar, JNTU, the Principal, UCEST, JNTU, Hyderabad and petitioner, it was observed that the institution has taken corrective action and no action is warranted on part of NCST. However, it was suggested that the TA and special leave may be reimbursed / granted in favour of the petitioner by the authority as per his entitlement and rules.
