Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri V Demudu and others of ST Mannedora community residing in Sambuvanipalem village of Visakapatnam District, Andhra Pradesh regarding construction of all-weather road.

Shri V Demudu and others of ST Mannedora community residing in Sambuvanipalem village of Visakapatnam District, Andhra Pradesh, vide their representation dated 20.07.2024 have stated that although their village does not fall under the Eco-Sensitive Zone of the neighboring Kambala Konda Wildlife Sanctuary, the Forest Department is intentionally not permitting the construction of an all-weather road under the developmental rights granted by the Forest Rights Act (FRA). They further alleged that in 2002, when Kambala Konda was declared a Wildlife Sanctuary, they were neither informed nor involved in the Gram Sabha. The petitioners have also alleged that the DFO is intentionally harassing them.

- 2. NCST vide notice dated 04.12.2024 sought facts and comments from the Collector & District Magistrate, District Vishakhapatnam and the District Forest Officer, Visakhapatnam within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authorities and the petitioner on 06.05.2025. Accordingly, a sitting notice was sent on 21.04.2025.
- In the sitting, the DFO, Visakhapatnam and petitioners were present. There was no communication from the Collector & District Magistrate, District Vishakhapatnam. The petitioner reiterated their earlier submission and requested for construction of all-weather road for connecting the village in Sambuvanipalem of Vishakapatnam District, Andhra Pradesh. The DFO (T), Visakhapatnam had furnished the Note on the issues raised by the petitioner alongwith Map. copy of Gazette of India Notification dated 28.4.17 regarding the Eco-Sensitive Zone, Kambala Konda Wildlife Sanctuary, copy of Andhra Pradesh Gazette dated 17.10.,2002 regarding Sanctuary Notification and copy of minutes of the fourth meeting of monitoring committee Kambala Konda Eco-Sensitive Zone conducted on 30.3.2024 at District Collector Chamber. Visakhapatnam held under the chairmanship of Collector & District Magistrate, Visakhapatnam. In the note it has been pointed out that the proposal have been verified and put up as agenda item for fourth ESZ monitoring committee Kambala Konda Wildlife Sanctuary on 30.3.2024. The committee unanimously decided to reject the proposal for the development of layouts in the Sambuvanipalem. The same was intimated to petitioner. The M/ s Amrutha Valley Estates Pvt. Ltd has filed a Writ petition No. 19046 of 2024 in the Hon'ble High Court of Andhra Pradesh for direction to the department to issue NOC on subject matter. The matter is subjudice before the Court.
- 4. After discussion with the DFO, Visakhapatnam and petitioners, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.
 - The petitioners are advised to submit all relevant papers to DFO, Visakhapatnam for examination, as discussed and shown in the sitting.
 - The District Administration, DFO in presence of representatives of ST community of said village may conduct survey of the said issue raised by the petitioners.
