## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Shri K. Srinivasulu and others regarding non-consideration of promotion.

Date of the Sitting: 97/11/2025, 4:40 PM Participants in the Sitting: As per Annexure NCST/SER-1404/TS/4/2024-SSW

Shri K. Srinivasulu, Shri P. Raju, Shri Nunavath Ravi, and Shri Muni, all directly recruited as Sub-Inspectors (Civil) in 2002 under the SC/ST quota and later promoted as Inspectors in 2010, have represented vide letter dated 19.05.2024 that despite completing the required six years of service, they were not considered for promotion to DSsP (Civil) under the 15% (for SCs) and 10% (for STs) quota. They state that as per G.O.Ms. No. 153 dated 05.10.2018, the seniority list includes only up to the 1998 batch, excluding subsequent batches like 2002, 2004, and 2007. They further refer to G.O.Ms. No. 5 of 2003, G.O.Ms No.22 of 2004, G.O.Ms No 2 of 2004, G.O.Ms.No.26 of 2009, G.O.Ms.No.130 of 2022 which mandates 15% reservation for SCs and 10% for STs in promotions, but in May/June 2023, out of 141 DSsP promotions, only 15 SCs out of 21 and 6 STs out of 14 were promoted, leaving 5 SC and 9 ST DSsP posts vacant. They request intervention to fill these vacancies from eligible 2002 batch officers to uphold justice and ensure proper implementation of the reservation rules for the panel year 2022-2023.

2. In this case, three sittings have been held so far. In the sitting held on 26.9.2025, the Commission recommended the following and minutes were sent to all concerned on 22.10.2025 -

After hearing to the petitioner and authority the following observations/recommendations are made and the action taken report may be submitted in 15 days.

- As assured during the hearing, the outcome of the higher level meeting at the CS to Government on 26.9.25 may be communicated to NCST.
- Rule of Reservations in promotions may be implemented and ad hoc promotions may be ordered
  to the eligible petitioners in the same manner as was done in the case of the 160-plus Inspectors
  of Police who were promoted to the rank of Deputy Superintendent of Police (DySP) in June 2023
  under the state-wide category, pending finalization of service rules.
- The Commission is of the strong opinion that it is essential to build up the morale of ST employees by positively considering their genuine plea to foster inclusivity. Hence, Chief Secretary to Government, Special Chief Secretary to Government, GAD, Special Chief Secretary to Government, Home Department, Telangana, and the Director General of Police, Telangana, may take immediate necessary action by the end of October 2025 without further delay.
- 3. As there is no reply from the authority The Commission has again decided to discuss the issue with the authority and the petitioner on 7.11.2025. Accordingly, a Sitting Notice was sent on 4.11.25.
- 4. The Spl.CS, GAD, Spl.CS, Home Department and DGP have attended the hearing. The petitioners have attended the hearing.
- 5. The petitioners reiterated their plea that adhoc promotions may be considered immediately as they have attained the necessary eligible conditions long time back and as Dy.S.P Level promotions can be given at HoD level, the same may be made.
- 6. The authorities have informed that a higher level meeting is scheduled on 11.11.25 at the Chief Secretary to Government and the issue will be appraised for further necessary positive decision. As and when the proposal is received, the remarks will be sought from Law Department and necessary action will be taken.

- 7. After hearing to the petitioner and authority the following observations/recommendations are made and the action taken report may be submitted before 30-11-2025.
  - The DGP, may take immediate necessary action in coordination with the Spl.CS Home, Spl.CS GAD and the Law Departments before 30th November 2025 to implement Rule of Reservations in the promotions, adhoc promotions may be ordered by considering the seniority from among eligible SC/ST officers in the feeder category, based on eligibility, seniority, and suitability, pending finalization of service rules.
  - Promotions may be ordered to the Petitioners in the same manner as was done in the case of the 160 plus Inspectors of Police who were promoted to the rank of Deputy Superintendent of Police (DySP) in June 2023, under the state-wide category.
  - As the petitioners are with the apprehension that once the new batch of recent Group I
    probationers join the service, the existing SC&ST list available may not be feasible for
    consideration and fresh exercise needs to be done again which will further delay the
    process, the same may be done at the earliest.
