## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case Shri Dharavath Kommalu, Gudur Mandal, Mahabubabad District regarding Alleged illegal alienation of ST land in Khammam city.

Shri Dharavath Kommalu S/o Lal Singh, R/o Damaravancha village, Gudur Mandal, Mahabubabad District, vide his representation dated 28-05-2025, has submitted that he is the General Power of Attorney holder of Nallapu Radha and that Plot No.40 out of Sy.Nos.85, 102 & 107, Khammam city and district, was gifted to her by her father. He stated that G. Venkata Ramesh illegally alienated the same through document No.4565/1993 dated 19-07-1993 to A. Venkatalaxmi, who subsequently transferred it to Nallamothu Raghupathi Rao through document No.2208/1997 dated 23-06-1997, and then to Polavarapu Sailaja through document No.3578/2000 dated 27-07-2000. The petitioner contended that these transactions are invalid, executed with false boundaries and wrong survey numbers, and requested that the Commission enquire into the matter.

- 2. NCST issued notice dated 14.7.2025 to the District Collector & Magistrate, District- Khammam for furnishing the facts and comments within 30 days from receipt of the Notice.
- 3. The Collector & District Magistrate, Khammam, vide letter no. DCO/C1/SSAA/0028/2025 dated dated 20-09-2025 has furnished the facts and stated that the documents were duly registered under the Registration Act, 1908 and subsequent transactions have also taken place through regular conveyance deeds. The Registration Department has no authority to adjudicate disputes concerning title, ownership, possession or boundaries, which fall within the jurisdiction of civil courts. No discrepancies or irregularities were noticed in the registered deeds and Sections 81, 82, and 83 of the Registration Act, 1908; being penal in nature, do not empower the department to cancel deeds. It was therefore observed that the petitioner's grievance does not fall under the Registration Department's purview and any remedy regarding ownership or cancellation lies before a competent court. The letter no. G/2016/2025 dated 6.8.2025 of the District Registrar; Khammam is enclosed in support of the fact and comments. Accordingly, requested to drop further action in the matter.
- 4. The petitioner requested for justice. Hence, NCST has decided to discuss the issue with the authority and the petitioner on 28.10.2025. Accordingly, a Sitting Notice was sent on 17.10.2025. The Collector & District Magistrate, Khammam, vide letter no. DCO/C1/SSAA/0028/2025 dated 27.10.2025 has sought exemption and deputed District Registrar to attend the sitting.
- 5. In the sitting the above officer and petitioner were present. The petitioner has alleged the boundaries to be false and there is an ambiguity in the survey numbers and reiterated his earlier submission and requested for justice. The Registrar, District Khammam has drawn the attending on the letter no. DCO/C1/SSAA/0028/2025 dated dated 20-09-2025 of Collector & District Magistrate, Khammam and stated that the District Registrar and District Administration of Khammam has no power to cancel the sale deed of the said plot. It will be more appropriate that the petitioner may approach the competent court.
- 6. After discussion with the District Registrar, Khammam and petitioner, the following recommendations are made and ATR may be submitted within 15 days from the receipt of the minutes.
  - a. The Revenue authorities may cause survey of the disputed land and submit a detailed report along with timeline of transfer of the said survey numbers to various individuals to NCST for further examination of the grievance.
