

**NATIONAL COMMISSION FOR SCHEDULED TRIBES**

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri B.Suresh, Superintending Engineer, TPC, Vidyut Soudha, Hyderabad regarding restoration of his position/promotion as Chief Engineer/Mechanical.

(NCST/SER-1820/TS/153/2024-RO-BHUV/RU-III)

Date of the sitting: 8.9.2025 at 7:05 PM

Shri B. Suresh, SE/TPC (former Chief Engineer), vide his representation dated 13.03.2024 has stated that he served as Chief Engineer/Mechanical in TSGENCO for over six years but was reverted to the lower cadre of SE without any notice, fault, or justifiable reason, which he claims is against service rules, principles of natural justice, and Supreme Court judgments. He contends that his reversion was arbitrary and discriminatory as the promotion of another officer, Sri B. Anandam, who was also promoted after 2014 and is facing an ACB trap case, was not cancelled. He argues that promotions granted before bifurcation and finalized allocation should not have been reviewed and that he had acquired lien on the post after completing five years as CE. He further asserts that the reversion caused him mental agony, humiliation, and financial loss, and cites relevant service regulations and government orders supporting his case. He requests the Commission to intervene and direct restoration of his position/promotion as CE/Mechanical with all consequential benefits, alleging that TSGENCO ignored his multiple representations and acted in violation of rules and court directives.

2. The Commission issued Notice to the Chairman & Managing Director, Telangana State Power Generation Corporation Limited on 23.01.2025 for furnishing the facts and comments within 30 days from receipt of the Notice.


3. The TGGENCO vide letter no. Dir/HR/CGM (Adm)/DS(Adm)/AS(Adm)/PO-B/06/2025 dated 22.02.2025 has informed that the after bifurcation under the A.P. Recorganisation Act, 2014, promotions made temporarily after 02.06.2014 were subject to court outcomes. Based on Hon'ble Supreme Court's directions dated 11.10.2022 and 31.10.2022 in Contempt Petition (Diary No.28852/2020) and the One-Man Committee reports, TGGENCO reviewed all promotions post-02.06.2014 and revised seniority, resulting in cancellation of 486 promotions, re-promotions of 450 employees and 95 reversions, including Sri B. Suresh as his senior, Sri K. Srinivasa Babu, was allocated from APGENCO. It was further informed that W.P. No.9108/2024 on the subject is pending before the Hon'ble High Court and that B. Suresh's case will be considered, as per his eligibility and vacancy position. The Commission was requested to close the case.

4. Thereafter, NCST made several correspondences with the authority and the petitioner but the issue could not be resolved. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.09.2025. Accordingly, a Sitting Notice was sent on 28.08.2025. The CMD, TGGENCO vide letter dated 3.9.2025 has sought exemption and deputed Director (HR & IR) and Chief General Manager (Admin) to attend the sitting.

5. In the sitting, the above officers of TGGENCO and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The officers of TGGENCO provided the letter no. CMD/Dir. (HR & IR)/CGM (Adm)/DS (P & R-T)/AS(P & R-T)/PO-B/06/2025 dated 3.9.2025 of the CMD, TGGENCO. In this letter, the chronological events and action taken by the management of TGGENCO in respect of the case of petitioner has been mentioned. It was further informed that W.P. No.9108/2024 and other cases on the same subject is pending before the Hon'ble High Court and that B. Suresh's case will be considered, as per his eligibility and availability of vacancy.

6. After discussion with the above officers of TGGENCO and petitioner, the followings observations were made.



- As the issue is subjudice, no action is warranted on part of NCST.
