## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri A. Sethilal, Officer (Retd.), MM-II, Telangana Grameena Bank regarding reduction of increments.

Shri A. Sethilal, Officer (Retd.), MM-II, Telangana Grameena Bank, Thirumalapur Branch, Kamareddy District, vide his rejoinder dated 22.08.2025, has stated that the Bank management has been harassing him by reducing 14 increments without any fault on his part and has exhibited a discriminatory and biased attitude towards him as an ST employee. He has alleged that the reply furnished by the Bank to his earlier representation dated 04.04.2019 was false and did not address his genuine grievances, which were instead treated as extraneous. He has requested that justice can only be ensured through a hearing with the Bank therefore sought the Commission's intervention for management, and

- The Commission issued notice to the Chairman, Telangana Grammeen Bank vide NCST letter dated 15.09.2025 seeking facts and comments within 15 days.
- The Chairman, Telangana Grameena Bank, vide letter dated 08.10.2025, has informed the Commission that Shri A. Sethilal, MM-II (Retd.), had joined the Bank on 05.04.1991 and served in various positions. During his tenure as Branch Manager, Thirumalapuram Branch (05.09.2008 to 17.01.2011), certain irregularities were found in loan sanctions leading to abnormal growth in advances, after which he was suspended and a departmental inquiry was held. A penalty of reduction by three stages in basic pay for two years was imposed on 16.11.2012. Later, he was promoted to Officer Scale-II on 03.03.2016, but fresh complaints were received in July 2016 from borrowers alleging that he had taken hand loans, leading to another disciplinary action. After due inquiry, his pay was reduced from ₹34,490/- to ₹31,705/- with cumulative effect, vide order dated 31.08.2018, and the appellate authority upheld the penalty. The Bank stated that all proceedings followed the principles of natural justice, and Shri Sethilal retired on 30.04.2023, receiving pension benefits. It was reiterated that there was no discrimination or harassment as alleged and requested the Commission to dispose of the representation as devoid of merit. This was sent to the petitioner vide NCST letter dated 24.10.2025.
- The Commission has decided to discuss the issue with the authority and the petitioner on 06.11.2025. Accordingly, a Sitting Notice was sent on 28.10.2025.
- The petitioner has attended the hearing. The authorities ie, Chairman, Telangana Grameena Bank, G.M, Telangana Grameena Bank have attended the hearing.
- The petitioner has reiterated his grievance that without any Departmental enquiry and giving an oppurtunity to defend himself, action was taken on him. Though he appealed before the Board, it was not considered which is againist the principles of natural justice. Neither the bank has incurred any loss nor any complaint is received against the petitioner, however after 4 internal audits they have initiated the Departmental proceedings and punishment is awarded. The petitioner further mentioned that only STs are targeted.
- The authority has mentioned there was a misappropriation in the bills where the cattle were purchased and 2 bills were missing and there is even the mismatch of the dates. Further stated that fake pattadars were given loans and loans were sanctioned without proper documents. The appellate authority ie, the Board has also upheld the punishment.
- 8. After hearing to the petitioner and the authority the following recommendations are made and ATR may be submitted in 30 days.
- a. The management of the bank is advised to re-examine the case impartially without any prejudice and submit a report to the board for further necessary action.


b. The petitioner is advised to submit all the documentary evidences in his favour to the bank management.
