## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Mood Eeru regarding land acquisition without due compensation.

**Date of the Sitting: 11/11/2025, 5:00 PM**

Sri Bhukya Devija, Sri Mudu Sakru (represented by his son and legal heir Shri Mood Eeru), Sri Banoth Bhavsingh (represented by his son Sri Banoth Sudheer), and Sri Dharavath Ramulu, all residents of Bhadradi Kothagudem District, Telangana, have jointly submitted a representation dated 02.09.2025 and alleged that their ancestral agricultural lands situated in Palvantha village and recorded in their names in the revenue records were acquired by the Government of Andhra Pradesh/Telangana through TS GENCO for the expansion of Kothagudem Thermal Power Station (KTPS) without payment of compensation or providing employment to the affected land losers, as earlier assured. They stated that during the land acquisition process, the Land Acquisition Officer and KTPS authorities colluded to exclude the names of the Scheduled Tribe Lambadi community landowners from the award and granted compensation only to non-ST persons. Despite repeated pleas, the authorities have refused to rectify the omission, allegedly demanding bribes for inclusion of their names. The petitioners have requested the Commission's intervention to ensure justice, payment of compensation, and employment benefits, terming the actions of the officials as cheating, land grabbing, and atrocity against ST landowners.


2. NCST vide notice dated 15.09.2025 sought facts and comments from the Collector & District Magistrate, District Bhadradi Kothagudem and Chairman & Managing Director, Telangana State Power Generation Corporation Limited within 30 days from receipt of the Notice. The reply was not received; hence, NCST has decided to discuss the issue with the authorities and the petitioners on 11.11.2025. Accordingly, a Sitting Notice was sent on 04.11.2025. There was no response from District Collector, Bhadradi Kothagudem. The CMD, TGGENCO vide letter dated 10.11.2025 has sought exemption and deputed Chief Engineer (Civil) of GENCO to attend the sitting.

3. In the sitting, the above officer from TGGENCO and petitioners were present. The petitioners have reiterated their earlier submission and requested for payment of Compensation, Employment Benefits and action against officials who were involved for cheating the ST land owners. The petitioners have informed their names have been in patatdar column and KTPS in Anubavadaru column till 2018 but later their names were removed and only KTPS is reflected.

4. The authority has informed that land losers certificate is not the criterion but the list of awardees of PDFs is the criterion and all those eligible were compensated by the then APSEB in 1960's and 1970's which is later transformed into AP GENCO and as TG GENCO after the reorganisation of the state. It is further informed that 6 Writ petitions are pending in Hon'ble Highcourt, 5 of them relate to the ownership as there are multiple claimants in the matter relating to the disputed land of approximately 17 acres.

5. After discussion with the authorities and petitioners, the following recommendations were made and action taken there and action taken report there on may be submitted within 30 days from receipt of the Minutes—

- The District revenue authorities and GENCO may address CCLA to establish the ownership and arrive at conclusion on the issue as the lives of poor and vulnerable tribals are affected without justice since past several decades.
- The petitioners are advised that in view of subjudice of WPs in Hon'ble High court no action is warranted on part of NCST.
