NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Pradip Kumar Bijali, president of Bhartiya Majdoor Sangh regarding reservation in contractual posts.

Shri Pradip Kumar Bijali, President of Bhartiya Majdoor Sangh has submitted a petition saying that SPM port, Kolkata has persistently failed to implement the reservation policy as mandated under the extant Office Memorandums (OMs) issued by the Ministry of Home Affairs and the Department of Personnel and Training (DoPT), which clearly states that reservation must be provided in all temporary appointments except those lasting less than 45 days. The Port Authority also reportedly does not maintain a separate roster register for such contractual posts, thereby violating the prescribed norms for ensuring social equity in recruitment.

- 2. NCST vide Notice dated 23.9.2025 has referred the matter to Chairperson, Syama Prasad Mookerjee Port, Kolkata for furnishing the facts and comments within 30 days from receipt of the Notice. The reply was not received; hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 10.11.2025. Accordingly, a sitting notice was issued to all concerned on 4.11.2025.
- 3. The Syama Prasad Mookerjee Port, Kolkata vide letter no. Ch/N-867 dated 7.11.2025 has sought exemption and deputed General Manager (M&S), SMPA along with Dy. Engineer Supdt. & Central Liaison Officer of SC/ST please.
- 4. In the sitting, the General Manager (M&S) alongwith other officers of Syama Prasad Mookerjee Port were present. The petitioner joined via phone. The petitioner reiterated his earlier submissions and stated that he belongs to SC Community. The officials of Syama Prasad Mookerjee Port, Kolkata has provided the letter no. vide letter no. Ch/N-869 dated 7.11.2025 which contains the facts and stated that the contractual engagements are purely on ad-hoc basis for fixed tenure and are not made against any sanctioned posts. Thus, maintaining post-based reservation roster for such category is not feasible.
- 5. During discussion it was observed that the Syama Prasad Mookerjee Port is not following the advisory issued by DoPT for reservation of STs in the temporary appointments.
- 6. After hearing both the sides, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes—

 Syama Prasad Mookerjee Port, Kolkata may re- examine the issue in view of the DoPT instructions for reservations to ST in temporary appointments 45 days or more.
