- The issue may also be referred to Internal Grievance Committee of ALIMS for re-examination of the points, as raised by the petitioner.
- An advisory may be issued for sensitization of Employees of ALIMS about the ST employees.

44. After discussion with the above officers of AIIMS, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the minutes.

3. In the sitting, the above officers of AIIMS were present and the petitioner could not attend due to some emergency. The officer of AIIMS informed that the petition has filed the application before the women commission and the department has also been referred to Interim Complaints Committee. Meanwhile, the department has withdrawn the charge of HOD, of CTVS from the said accused.

NCSST vide notice dated 13.11.2025 sought facts and comments from the Director, All India Institute of Medical Sciences within 3 days from receipt of the Notice. The reply was not received, hence, NCSST decided to discuss the issue with the authority and the petitioner on 04.12.2025. Accordingly, a Sitting Notice was sent on 26.11.2025. The Director, AIIMS vide letter dated 4.12.2025 has sought exemption and deputed Dy. Secretary, AIIMS and Sr. Administrative Officer to attend the sitting.

Mrs. Lmaanilie, Nursing Officer, AIIMS, New Delhi, vide her petition dated 07-11-2025, has stated that she was subjected to severe verbal abuse and harassment by Dr. A.K. Bisoi, HOD CTVS on 29-09-2025 during an emergency meeting at the CTVS-ICU faculty room, where he allegedly used vulgar and discriminatory remarks against her, including comments referencing another faculty member and insulting her work. She further stated that in another occasion he again made an abusive remark, creating a humiliating and hostile environment for her as a woman and as a member of an ST community. She added that the incident reflects gender-based and caste-related targeting, and that although she has submitted a grievance to the AIIMS administration and an internal Complaints Committee has been constituted, she seeks the intervention of the Commission for appropriate investigation and protection.
