Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Dulari Marndi, W/o Late Uday Nath Marndi, a resident of Kucheibudi, Ichinda, Ward No.15, PO/PS- Rairangpur, District – Mayurbhanj, Odisha regarding alleged atrocity on him by advocate, Shri Uma Pada Mandal and his brother-in-law.

Smt. Dulari Marndi, vide petition dated Nil has stated that she and her sister were brutally attacked by Advocate Uma Pada Mandal and his associates when she confronted him regarding alleged forgery of her signatures in court documents related to the demolition of her house. She alleges severe physical assault, molestation, threats to life, theft of jewellery and continued harassment, all witnessed by her daughter who also recorded parts of the incident. She submits that although an FIR was filed and the SDPO and Additional SP initiated inquiries, no concrete action has been taken, and the accused continue to intimidate her. She further states that her house—constructed on land gifted by her father and occupied by her for 32 years—was illegally demolished on 08.11.2024, and her belongings, including cash, were seized by police without due process, despite a civil case regarding the land being sub-judice. She mentions past harassment by private individuals claiming ownership of her land, illegal actions by police officials, and obstruction in obtaining court documents. She also states that the NCW, during a video conference on 22.01.2025 observed that the actions taken against her were illegal and sought a report from authorities. She requests immediate intervention, protection, restoration of her property, and action against the responsible persons, as she and her children are left without shelter or resources.

2. NCST vide notice dated 27.02.2025 sought facts and comments from the District Collector & Magistrate, District:-Mayurbhanj and Superintendent of Police, District:-Mayurbhanj within 15 days from receipt of the Notice.

3. The Collector & District Magistrate, Mayurbhanj vide letter no. 1015/Judl. dated 17.03.2025 has informed that the petitioner's representation was examined. In the reports of the SP Mayurbhanj, Sub-Collector Rairangpur and the Tahasildars of Rairangpur and Jamda, which indicate that notices were issued for hearing on 12.03.2025 an SC/ST case (No.24/25 dated 30.01.2025) and a counter-FIR (No.358 dated 18.12.2024) are under inquiry and the petitioner is not landless. It is reported that the disputed land belongs to Smt. Shantilata Mohanta, who had obtained a civil decree in CS No.242/2015, and after the petitioner allegedly violated an injunction in CS No.25/2017, possession was delivered to the owner on 08.11.2024, followed by demolition of the petitioner's unauthorized construction; allegations of police theft or abuse were found false. Regarding the incident of 18.12.2024, it is stated that a case (Rairangpur Town PS Case No.360/24) has been registered against Advocate Umapada Mandal and his brother-in-law for assault, caste abuse, and threats, and the matter is under investigation. This was sent to the petitioner vide NCST letter dated 24.03.2025.

4. The Superintendent of Police, Mayurbhanj vide letter no. 526/DHRPC dated 07.03.2025 has informed that the case was enquired into by the Addl. SP, Rairangpur, whose findings reveal that the disputed land belongs to Smt. Shantilata Mohanta, in whose thatched house the petitioner's family had been tenants since 2008, and due to non-payment of rent and refusal to vacate, a civil decree in CS No.242/2015 directed delivery of possession. Despite this, the petitioner constructed a three-storied building, allegedly violating an injunction in CS No.25/2017, after which, on 08.11.2024, the Civil Court Commissioner with police handed over possession to the owner and the unauthorized structure was demolished; her household articles were seized for safe custody, and allegations of police theft or abuse were found false. Regarding the incident of 18.12.2024, it is reported that after the petitioner confronted Advocate Uma Pada Mandal over alleged forgery, he and his brother-in-law assaulted her, used caste-based abuses, and threatened to kill her, based on which Rairangpur Town PS Case No.360/24 under BNS and SC/ST (POA) Act has been registered and is under investigation. This was sent to the petitioner vide NCST letter dated 01.04.2025.

5. Thereafter there were several communications but the issue could not be resolved. Hence, NCST has decided to discuss the issue with the authority and the petitioner on 17.12.2025. Accordingly, a Sitting Notice was sent on 08.12.2025. The District Collector, District – Mayurbhanj vide letter dated 15.12.2025 has sought exemption and deputed ADM, Mayurbhanj to attend the sitting. The SP, District – Mayurbhanj vide letter dated 15.12.2025 has sought exemption and deputed Addl. SP, Rairangpur to attend the sitting.

6. In the sitting, the ADM, Mayurbhanj and Addl. SP, Rairangpur were present and there was no communication from petitioner. The ADM, Mayurbhanj has provided the letter no. 4595/Judl dated 15.12.2025 of District Collector & Magistrate, Mayurbhanj which indicates the facts and comments and latest position of the case. In the letter, it has been pointed out that the case is sub judice. The Addl. SP, Rairangpur has also provided the supporting documents in respect of the facts and comments of the District Police.



7. After discussion with the above officers, it was observed that the no action warranted on part of NCST, as the case is subjudice.
