

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Tippanna H. Talwar, retired Principal, Alur Venkata Rao Smarak PU College, Mugad regarding delay in release of pension, increments and arrears by Sarvodaya Shikshana Trust, Hubli.

Shri Tippanna H. Talwar, Dharwad, vide his representation dated 21.07.2025, has stated that he is an ST, retired Principal of Alur Venkata Rao Smarak PU College, Mugad, and that despite retiring on 31.05.2022 after 36 years of service, his Service Record Book was illegally withheld by Sarvodaya Shikshana Trust, Hubli. He adds that this fact was admitted by the Director, PU Board (Mrs. Sindhu Rupesh) in her letter. He states that due to the SR Book being kept on hold for nearly two years, he did not receive pension, increments, arrears, and leave encashment on time, causing severe financial loss. He claims total damages of approximately ₹1.5 crores and alleges intentional negligence and favouritism by the Principal Secretary, School Education, Director, PU, DDPU Dharwad, and the Trust Secretary, amounting to offences under the Prevention of Corruption Act. He further states that, as an ST, his constitutional and legal rights have been suppressed and prays for legal action and compensation for the losses suffered.

2. NCST vide notice dated 22.09.2025 sought facts and comments from the Director Department of School Education (Pre University), Govt. of Karnataka within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 17.12.2025. Accordingly, a Sitting Notice was sent on 08.12.2025.

3. In the sitting, the Director, Department of School Education (Pre University), Govt. of Karnataka and petitioner joined through Video Conference. The petitioner has reiterated his earlier submission and requested for justice. The Director, Department of School Education (Pre University) informed that there are two groups / factions claiming to be the management of the said college. They are (1) The Sole Trustee, Sarvodaya Education Trust, Siriganda Mission Compound, Shathinagara, Dharwad. (2) The Secretary, Sarvodaya Education Trust, Aravatagi, Dharwad, Adiveshwara Sadana, Vemana Beedhi, Dharwad District. The petitioner has filed a W.P No. 105276/2023 before the Hon'ble High Court of Karnataka. The Hon'ble Court vide order dated 05.12.2023 has directed to petitioner and authority (the factions of the management) for considering his request. Thereafter, the Secretary, Sarvodaya Education Trust, Aravatagi, Dharwad, Adiveshwara Sadana, Vemana Beedhi, Dharwad District has submitted a proposal on 22.1.2024. The Dy. Director, Dharwad has taken action in consultation with the Finance Department for release of salary. In regard to release of Annual increments, EL encashment and Addl. Increments in favour of the petitioner, the management has not submitted the proposal to the Dy. Director, Dharwad. The Dy. Director, Dharwad vide letter dated 28.4.2025 has take up the matter with the factions of the management Institute. However, no step has been taken by either of the factions. Hence, there is no fault of the officers of Education Department, as alleged by the petitioner. The Department will take up the matter with the concerned factions of the management of the institute.

4. After discussion with the officer and petitioner, the following recommendation was made and action taken there on may be submitted to NCST within 30 days from receipt of the minutes.

- The Prl. Secretary, School Education and Literacy Department, Govt. of Karnataka is advised to re-examine the issue and direct the concerned department to release the pension and other terminal benefits in favour of the petitioner.
- Petitioner is advised to meet the Director, Department of School Education (Pre University), Govt. of Karnataka for guidance for release of pension and other issues.
