

## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Ms. Divya N, Senior Assistant, Zone-III)Karimnagar R.O.), Registration and Stamps, Government of Telangana non allocation of cadre by the Administration of Registration and Stamps Department, Govt. of Telangana.

**NCST/SER-2681/TS/737/2025-RO-BHUV/RU-III**

**Participants in the Sitting: As per Annexure**

Ms. N. Divya, Senior Assistant, Registration and Stamps Department, Government of Telangana, vide her representation dated 12.09.2025, has complained of injustice in cadre allocation made under G.O. Ms. No. 317 dated 06.12.2021, stating that despite being a Scheduled Tribe employee and a local candidate of Sangareddy District (Zone-VI, Charminar Zone) by birth and education, she was wrongly allocated to Zone-III (Karimnagar) during cadre restructuring. She has stated that her post originally belonged to the erstwhile District Cadre of Medak (Zone-VI) and that her seniority at Serial No. 106 was ignored, while juniors were retained in Zone-VI in violation of Para 20 and Para 21 of G.O. Ms. No. 317 and the Presidential Order, 2018. The petitioner has further informed that she submitted an appeal in January 2022, re-submitted her grievance on the GO-317 Grievance Portal vide acknowledgment TGGR-2024-6489 dated 08.06.2024, and also sent a reminder to the Secretary, Revenue (Registration) on 10.07.2025, but no action has been taken. She has also alleged denial of information under RTI regarding the rationale of her allocation. The petitioner has requested the Commission to investigate the matter and recommend her reallocation to Zone-VI in accordance with her native status, seniority, and ST protections.

2. NCST vide notice dated 23.09.2025 sought facts and comments from the Commissioner & Inspector General of Registration and Stamps, Registration and Stamps Department, Govt. of Telangana within 30 days from.

3. The Registration and Stamps Department, Govt. of Telangana, vide letter 07.11.2025, has informed that the petitioner Smt. N. Divya, Senior Assistant, is holding a zonal cadre post, and that allocation of zonal and multi-zonal cadre posts under G.O. Ms. No. 317 falls exclusively within the competence of the Government of Telangana. He has stated that the Government has already issued the relevant allocation orders in this regard and, therefore, the matter has been referred to the Government for submission of detailed facts and report to the Commission. It has further been intimated that after receipt of the report from the Government, the same will be forwarded to the Commission for further consideration.

4. The Commission has decided to discuss the issue with the authority and the petitioner on 18.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner & Inspector General of Registration and Stamps, Govt. of Telangana vide letter dated 17.12.2025 has sought exemption and deputed Addl. Inspector General (FAC) to attend the sitting.

5. In the sitting, the Addl. Inspector General (FAC), Registration and Stamps, Govt. of Telangana and petitioner were present. The petitioner has reiterated the facts and comments and requested for justice. The officer from Registration and Stamps, Govt. of Telangana has provided the copy of letter no. 29661/Regn.I/2025 letter dated 28.11.2025 of Special Secretary to Govt., Revenue (Registration & Stamps) Department, Hyderabad. In the letter, point wise reply on the issue raised by the petitioner had been mentioned. It was also informed that the matter has been referred to the Government for submission of detailed facts and report. After receipt of the report from the Government, the same will be forwarded to the Commission for further consideration.

6. After discussion with the above officer of Registration and Stamps, Govt. of Telangana and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the Minutes.

- It is observed that the allocation is made in accordance with terms of G.O. Ms. No 317 and there is no violation of Presidential Order 2018. However it is recommended that the petitioners plea of posting in the nearest feasible location may be considered in accordance with the existing provisions.
- TA and Special Leave may be reimbursed / granted in favour of the petitioner as per her entitlement and rules.
