## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatotu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri Subhash S.H. State President, Karnataka State Tribals Hitharakshna Sangha, Mysuru, Karnataka regarding negligence by the Government of Karnataka in providing security.

Shri S.H. Subhash, State President, Karnataka State Tribals Hitharakshna Sangha, Mysuru, vide his representation dated 04.09.2025 has stated that despite multiple complaints regarding life threats from individuals who allegedly obtained fake ST caste certificates, the Government of Karnataka, including senior police authorities such as the ADGP, State Intelligence has withdrawn the protection earlier provided to him and his family without notice. He submits that he has approached the Hon'ble Prime Minister, Hon'ble President of India Hon'ble Home Minister, Ministry of Tribal Affairs, Chief Secretary, Govt. of Karnataka, DG & IGP Karnataka but no effective action has been taken. The petitioner alleges continuous negligence by State authorities despite directions from various constitutional offices, and seeks immediate restoration of security at his new address in Mysuru.

2. NCST vide notice dated 03.11.2025 sought facts and comments from the Director General of Police, Karnataka Police, Government of Karnataka within 15 days from receipt of the Notice. There was no reply from authority, hence, NCST discuss the issue with the authority and the petitioner on 17.12.2025. Accordingly, a Sitting Notice was sent on 08.12.2025.

3. In the sitting, the petitioner was present but there was no communication received from the concerned authority. The petitioner has pointed out various names who has obtained fake ST certificate and holding the higher posts in the State Govt. of Karnataka and actively working in the politics.

4. After discussion with the petitioner, the following recommendations were made.

- The petitioner is advised to submit name of the candidate (his/ her native place, present postal address), who obtained fake ST certificate to the NCST, as discussed in the sitting. After receipt of the detail, the matter will be taken up with the concerned authority.
- The DGP, Govt. of Karnataka is advised to consider the request of the petitioner for providing security in view of threat to his life considering the sensitiveness of the issue.
