Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt Islavath Priyanka regarding financial fraud, cheating and caste-based abuse by Mr. K. Sudhakar Raju, Head Constable, National Police Academy (NPA), Shivrampally, Hyderabad.

Smt Islavath Priyanka, vide her complaint has submitted that she belongs to the Scheduled Tribe community and has been a victim of financial fraud, cheating and caste-based abuse by Mr. K. Sudhakar Raju, Head Constable, National Police Academy (NPA), Shivrampally, Hyderabad. She stated that on the false assurance of arranging her husband's transfer to Hyderabad and securing a Central Government job for her brother, Mr. Sudhakar Raju, along with one Mr. Srikanth Pawar (who falsely impersonated an IPS officer), induced her to transfer an amount of ₹10,00,000/- to various bank accounts. It was later informed by the Karad Police Station, Maharashtra, that the said persons were involved in large-scale fraud, and during investigation it was revealed that Mr. Sudhakar Raju misused his official NPA identity card, facilitated fake IPS identity documents, uniforms and access to the NPA campus. The petitioner further alleged that despite issuance of cheques and a written agreement, the cheques were dishonoured, and upon demanding repayment, she was abused, threatened and humiliated with caste-based slurs by Mr. Sudhakar Raju and his wife, including abusive voice messages. She has stated that even after serving a legal notice, no repayment has been made and has sought strict action, recovery of her money and protection from further harassment.

2. NCST issued notice to the Commissioner of Police, Cyberabad vide NCST letter dated 24.09.2025 seeking facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 19.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner of Police, Cyberabad vide letter dated 13.12.2025 has sought exemption and deputed ACP, Rajendranagar Division to attend the sitting.

3. In the sitting, the ACP, Rajendranagar Division, Cyberabad was present and petitioner joined via phone. The petitioner has reiterated her earlier submission and requested for justice. The ACP, Rajendranagar Division, Cyberabad has provided a letter no. 101/C3/NCSC/Cyb/2025 dated 10.12.2025 which contains the facts and comments from the O/o Commissioner of Police, Cyberabad. In the letter, it has been informed that the caste-based allegation against Sudhakar Raj does not stand, as he belongs to the SC-Mala community. Furthermore, the financial offence has already been registered against him at Karad Police Station, Maharashtra, vide Cr. No. 1651/2024. There was an agreement between the petitioner and accused on 10.1.2025. A copy of the agreement on stamp paper, copy of cheque which was bounced are enclosed. The petitioner has been advised to be pursued before the appropriate legal forum.

4. After discussion with the ACP, Rajendranagar Division, Cyberabad and petitioner, the following recommendations were made and action taken there on may be submitted within 30 days from receipt of the minutes.

- The petitioner is advised to file a cheque bounce case against the accused Shri Sudhakar Raju as the matter does not come under the purview of SC ST POA Act.
- The police department may coordinate and expedite the process for the recovery of the amounts and may take necessary action on the alleged threatening of the petitioner by Shri Sudhakar Raju.
