Minutes of the Sitting held under the Chairmanship of Shri Jatotu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Kethavath Nari Bai, W/o Late Khethavath Chandu, Dwarakapuram, Chaithanyaapuri, Dilsukhnagar, Hyderabad, Telangana State regarding brutal murder of her husband and the continued harassment faced by her family.

Smt. Kethavath Nari Bai, wife of Late Khethavath Chandu, vide her complaint dated 09.08.2025, has sought the Commission's intervention regarding the alleged conspiracy, caste-based harassment, and murder of her husband, an ST (Lambada) leader, on 15.07.2025. She has stated that her husband was targeted by certain party associates after opposing illegal money collection from poor SC/ST families and exposing attempts to illegally sell government (Bhoodan) land in Kuntloor Village, Ranga Reddy District. Despite earlier cases under the SC/ST (Prevention of Atrocities) Act and continued threats, he was brutally shot dead with alleged caste abuses, indicating a targeted killing. The petitioner has requested arrest and prosecution of the accused, protection to her family, and grant of compensation and rehabilitation, alleging influence over the investigation.

2. The Commission issued notice to the Commissioner of Police, Police Commissionerate, Rachakonda, Government of Telangana, vide NCST letter dated 18.09.2025 seeking facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 19.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner of Police, Hyderabad vide letter dated 12.12.2025 has sought exemption and deputed ACP, Malakpet Division to attend the sitting.

3. In the sitting, the ACP, Malakpet Division, Hyderabad was present and there was no communication from the petitioner. The ACP Malakpet Division, Hyderabad provided a letter no. 549/OW/ACP-MLKP/2025 dated 16.12.2025 which contains the facts and comments alongwith action taken of Police Department in the matter. In the letter, it has been informed that the police has taken prompt and decisive legal action including registration of case, arrest of all accused and filing of charge sheet, Opposition to bail and initiation of preventive detention proceedings under the Telangana Prevention of Dangerous Activities Act to safeguard public order. The proposal for compensation has been processed and necessary action will be taken after receipt of the orders from the concerned department.


4. After discussion with the ACP, Malakpet Division, Hyderabad, it is concluded that no action is warranted on part of NCST, as necessary legal action is already been taken and the petitioner may approach NCST anytime if there is any pending action from the Department concerned.
