**NATIONAL COMMISSION FOR SCHEDULED TRIBES**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. J Sunitha, DAE Housing Colony, ECIL Post, Hyderabad, (Telangana) regarding Financial Fraud and Non-Registration of Plots of M/s Fortune99 Homes (NCS Fortune Med City) by its Managing partner.

Smt. Jatoth Sunitha W/o Shri Jatoth Motila vide her petition dated 28.07.2025 has alleged large-scale financial fraud and denial of registration of open plots purchased by her and other ST families from Fortune99 Homes, promoted by Mr. Madhirala Rosi Reddy a Managing partner of the firm, Mucherla Village, Kandukur Mandal, Ranga Reddy District (Telangana). She stated that between 2020 and 2024, they paid the entire plot cost of about ₹1.38 crores across multiple buyers based on promises of a 100-acre approved venture, free registration and assured benefits. However, despite repeated assurances, registration has not been done and instead the accused is reselling the same plots under different company names and brandings, reassigning previously allotted plots and registering plots only for partial payees. The petitioner alleged misrepresentation, multiple fraudulent entities, deliberate non-communication, threats and intimidation by the promoter. Hence, requested to do the justice.

2. In this matter, a sitting was held on 09.09.2025. In the sitting, the following recommendation were made and minutes were circulated on 23.9.2025 for submission of ATR within 30 days from receipt of the Minutes.

- The petitioner is advised to file a complaint against the Managing partner of the firm i.e. Fortune99 Homes in the Police Department.
- The Police department of the concerned district is also advised to take immediate action against the accused, as assured by them in the sitting.
- The District Administration, Rangareddy is also advised to cooperate and guide the petitioner for possession of their plots.
- The Revenue and Police Department may investigate the fraudulent practices, secure registration of their plots, protect the rights of affected ST families, and prevent further illegal sales by arresting the malpractice of brokers and landlords.
- The commissioner HMDA may attend with the details of layout, year from which registrations have started and number of registrations that have happened and the vacant plots.
- The District Registrar may make temporary ban on the registrations in the said layout to avoid further complications.
- The HMDA may check and cancel the permissions of the said layouts which have changed their names of the ventures and has fraudulently made offers and cheated the customers on the name of pre-launch offers."

3. The ATR was not received from the concerned authority, hence, NCST decided to discuss the issue with the authority and the petitioner on 18.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner of Police, Rachakonda vide letter dated 10.12.2025 has sought exemption and deputed Assistant Commissioner of Police, Ibrahimpatnam Division, Rachakonda to attend the sitting.

4. In the sitting, the Assistant Commissioner of Police, Ibrahimpatnam Division, Rachakonda and Husband of petitioner were present. The representative of the petitioner has stated that the possession of the plot has not been given by the land lords. The agencies involved in the matter are also not taking corrective action against the land lords. The Assistant Commissioner of Police, Ibrahimpatnam Division, Rachakonda has provided the letter bearing no. 85/C6/NCST/RCK/2025 dated 11.12.2025 of Commissioner of Police, Rachakonda which contains the facts and comments in the matter. In the letter, it has been informed that the case has been Registered under respective sections and reported at Hyderabad Green Pharma City PS, of Rachakonda and is under investigation for collection of documentary evidence. After collection of evidence, the case may be finalised on the basis of merits.

5. After discussion with the Assistant Commissioner of Police, Ibrahimpatnam Division, Rachakonda and Husband of petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the Minutes.

- The registrations may be stopped on the said survey number by the District Registrar, to avoid further complications.
- Stringent action may be taken on the original landlord and the developer for the alleged malpractices.
- The commissioner, HMDA, District Registrar, Registrations Department may attend to the next scheduled date of hearing.



