Jamachakram Ramya, Srikakulam, Andhra Pradesh regarding Non-Implementation of Reservation for Scheduled Tribe in Dr. B.R. Ambedkar University, Etcherla, Srikakulam (Andhra Pradesh).

Shri Jamachakram Ramya, S/o Laxmana Rao, resident of Kanchodupeta Village, Saravakota Mandal, Srikakulam District, Andhra Pradesh, vide his/her representation dated 20-08-2025 has submitted that he/she belongs to ST (Kapu Savara) community and possesses B.Com qualification along with DCA and PGDCA, with more than six years of experience as a Computer Operator. The petitioner has alleged that Dr. B.R. Ambedkar University, Etcherla, Srikakulam District, Andhra Pradesh has not implemented the prescribed 6% reservation for STs in contractual recruitments and has allegedly filled several posts without notification and without following the rule of reservation. It has been stated that despite submission of bio-data, no response was received from the University authorities and only about 1% posts have been allotted to ST candidates, causing injustice and violation of constitutional provisions. The petitioner has therefore requested the Commission to intervene and take suitable steps for allotment of the post of Computer Operator or any suitable contractual post by proper implementation of the reservation policy for STs.

2. NCST issued notice to the Registrar, BRAU, Srikakulam on 26.08.2025 seeking facts and comments within 30 days from receipt of the Notice. Dr. B.R. Ambedkar University, Srikakulam, vide letter no. BRAU/Estt.Sec-I/2025-26 dated 09.09.2025 has informed that at present all sanctioned posts in the University are adequately filled and there are no vacancies. It has been stated that as and when vacancies arise in future, the University will initiate recruitment through due procedure and strictly adhere to the Rule of Reservation. The Registrar has further clarified that several unsolicited job applications are being received despite no advertised vacancies, and employment cannot be offered without a formal recruitment process. It has been assured that all eligible candidates may apply once posts are duly advertised and their applications will be considered as per University norms, requesting the Commission's support in communicating this position to prospective applicants.

3. The NCST decided to discuss the issue with the authority and the petitioner on 18.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025.

4. In the sitting, the petitioner joined via online mode. But there was no communication from the Registrar, BRAU. The petitioner has reiterated her submission and requested for providing suitable job in BRAU.

5. After discussion with the petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the minutes, for deciding further course of action in the matter.

- The management of BRAU may submit details of total sanctioned posts (Both for Teaching and Non- Teaching), Filled posts and vacant posts along with posts reserved for STs.
- The details of out sourced/ contractual posts (Both for Teaching and Non- Teaching) along with ST candidates may be furnished.
- The details of employees who joined BRAU in last two years alongwith their category may be furnished.
