Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Ms. Mudavath Sushma, H.no. 2-3-71 121, Reliable Prayer House, Sathyanagar Colony, Uppal, Hyderabad regarding Filling up of the Backlog Vacancies of ST Category – Medical Officer Unani Posts.

**Participants in the Sitting: As per Annexure**

Ms Mudavath Sushma, Uppal, Hyderabad, District Rangareddy, vide her petition dated 16.09.2025 has stated that she completed BUMS in 2024 and internship in April 2025, and is the first woman from Zone-II belonging to ST category to graduate in this field. She submits that under Notification No. 01/2023 dated 13/07/2023, only 4 candidates were recruited against 7 notified posts of Govt. Medical Officer (Unani), leaving 3 ST backlog vacancies unfilled. She further states that two selected candidates (Katravath Narendra Nath and Badavath Suryam) had applied while still undergoing internship and were not fully eligible at the time of application. She requests issuance of a backlog notification for filling the remaining ST category vacancies, stating that she holds all required documents including permanent registration and original degree.

2. NCST issued notice to the Director, AYUSH Department, Government of Telangana on 22.09.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 18.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Director, Ayush Department vide letter dated 17.12.2025 has sought exemption and deputed Addl. Director (Unani), Ayush Department to attend the sitting.

3. In the sitting, the Addl. Director (Unani), Ayush Department, Government of Telangana was present and petitioner joined via Video Conference. The petitioner has reiterated her submission and requested for Advertisement of backlog posts by the Ayush Department. The Addl. Director (Unani), Ayush Department, Government of Telangana has provided the letter bearing no. 4252/B.2/Unani/2025 dated 16.12.2025 of the Director, Department of Ayush, Govt. of Telangana. In the letter, the detailed clarification regarding posts in question have been mentioned. The proposal for filling up the said (3) ST backlog posts in the category of Medical Officer (Unani) have been addressed to Govt. of Telangana. Further, a reminder has also been issued on 15.12.2025. Soon after the receipt of Govt. orders, the notification will be issued for filling up the said posts.

4. After discussion with the Addl. Director (Unani), Ayush Department, Govt. of Telangana and petitioner, the following recommendations were made.

- The Director, D/o Ayush, Govt. of Telangana is advised to issue the Notification for backlog vacancies immediately, after receipt of the orders from Health & Family Welfare, Govt. of Telangana, as mentioned in the letter dated 15.12.2025.
- The petitioner is also advised to follow up with the D/o Ayush, Govt. of Telangana regarding advertisement of backlog posts for STs.
