Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. C. Mani Bhai, S/o Chatru Nayak, Gopanapalli Tanda, Sherlingampalli Mandal, Ranga Reddy District regarding illegal transfer of their land in the name of Raju Yadav and others of the same village.

Smt. C. Mani Bhai, resident of Gopanapalli Tanda, Sherlingampalli Mandal, Ranga Reddy District, vide his representation dated 11-10-2025 has stated that three acres of land belonging to his late father, situated at Gopanapalli Tanda behind the Wipro area, have been illegally transferred through pattas by his brothers without informing or obtaining consent of the sisters. He has further alleged that certain private persons, namely Raju Yadav and others, are threatening and abusing the family, falsely claiming ownership of the said land. The petitioner has asserted that the family has lawful rights over the land and that the original documents are in their possession, and has requested the Commission's intervention for restoration of the said land to them.

2. NCST notice to the District Collector & Magistrate District-Rangareddy and Commissioner of Police, Cyberabad vide NCST letter dated 21.10.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 19.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner of Police, Cyberabad vide letter dated 13.12.2025 has sought exemption and deputed ACP, Madhapur Division, Cyberabad.

3. In the sitting, the ACP Madhapur Division, Cyberabad was present and petitioner joined via phone. The petitioner has reiterated her earlier submission and requested for justice. The ACP Madhapur Division has provided a letter no. 14/SC&ST/ACP-Mdpur/Cyb/2025 dated 18.12.2025 and stated that the petitioner has not lodged any complaint at police station, Gachibowli regarding insult and threatened her in abusive language and also not filed civil suit before any competent court with regard to the land matter. He has also alleged that if the petitioner lodges any complaint before the Police in future disclosing a cognizable offence, the same will be registered and action will be initiated against the concerned in accordance with law.

4. After discussion with the ACP Madhapur Division, Cyberabad and petitioner, the following recommendations were made and action taken there on may be submitted within 30 days from receipt of the minutes.

- The petitioner is advised to file a written complaint before the appropriate authorities of Revenue and Police Departments.
- The occupation of the said land between 1978-2012 may be ascertained by the Revenue Department and Revenue Department may conduct a detailed enquiry and demarcate the boundaries of the disputed land. It may also be clarified as how the Gairan land is regularised.
- Police Department may give protection to the petitioners family till the finality of the dispute.
- The District Collector, Rangareddy may attend to the next scheduled date of hearing.
