## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatotu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Nenavath Jagan Mohan regarding continuous harassment, threats, false criminal cases, and atrocities by persons associated with M/s Samooha Projects Pvt. Ltd.

Shri Nenavath Jagan Mohan, vide his representation dated 16-07-2025 has alleged regarding continuous harassment, threats, false criminal cases and atrocities by persons associated with M/s Samooha Projects Pvt. Ltd. in collusion with police officials, mediators and a politically influential person. He has also stated that multiple FIRs registered during 2022-2023 at various police stations are fabricated, that he and his family were coerced into signing blank stamp papers, cheques, and bonds under threats and that defamatory messages were circulated against them. He has further stated that due to the harassment, he has suffered partial paralysis and speech impairment, his son is undergoing psychiatric treatment, and his wife and daughter are living in constant fear and social ostracism. Hence, do the justice.

2. The Commission issued notice to the Commissioner of Police, Police Commissionerate, Rachakonda, Government of Telangana on 31.07.2025 for seeking facts and comments within 10 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 19.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Commissioner of Police, Rachakonda, Government of Telangana vide letter dated 10.12.2025 has sought exemption and deputed ACP, Ibrahimpatnam Division, Rachakonda to attend the sitting.


3. The sitting was pre-scheduled on 18.12.2025 at 6:25 PM. In the sitting, the ACP, Ibrahimpatnam Division, Rachakonda and petitioner were present. The petitioner has reiterated his submission and requested for protection and justice. The ACP, Ibrahimpatnam Division, Rachakonda has provided the letter bearing no. 109/C6/NCST/RCK/2025 dated Dec, 2025 of Commissioner of Police, Rachakonda Government of Telangana. In the letter, detailed report has been mentioned. It was also informed that the cases are under investigation. After investigation the cases will be finalised on the basis of merits. The allegations made by petitioner are falls and baseless.

4. After discussion with the ACP, Ibrahimpatnam Division, Rachakonda and petitioner, the following recommendations were made and action taken report thereon may be submitted to NCST within 30 days from receipt of the Minutes.

- The petitioner is advised to submit the details of the ownership documents duly catalogued and indexed to examine for further necessary action by NCST.
- Meanwhile the Revenue Department and HMDA may examine the Registration documents and and Gift deeds as claimed by the petitioner.
- The police Department may take necessary action against the threatenings and defamatory messages claimed to be received by the petitioner.
- The authorised officers from Revenue and HMDA Departments may attend to the next scheduled date of hearing along with the Police Department.
