Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri P. Phool Singh Nayak, President, Sevalal Mallanna Tribal Labour Colony (Thanda) Association regarding providing basic amenities to 250 tribal families of Tumkunta Municipality, Shamirpet mandal of District- Medchal, Telangana.

Shri Phool Singh Nayak, vide his representation dated 26.10.2021, has stated that around 250 poor ST families belonging to Sevalal Mallanna Labour Colony, Devaryamjal Village, Tumkunta Municipality, Shamirpet Mandal, Medchal District, Telangana, have been residing as hut dwellers for the last 20 years but have not been provided with basic civic amenities such as electricity connection, water supply and house tax numbers. He has further submitted that despite representations made to the local MLA and concerned Ministers, no action has been taken by the authorities. He urgently request that the District Magistrate take necessary action to provide these basic facilities and improve living conditions for these long-standing, marginalized communities. He wants the Commission to intervene in this matter.

2. In this matter, the sittings were held on 10.09.2024 and 6.1.2025. In the last sitting held on 6.1.2025, the following recommendations were made. The minutes were circulated on 21.1.2025 to all concerned.


- Commissioner, Endowments Department, Telangana vide Letter No.L4/16211/2024 Dated 4.1.25 has submitted that Hon'ble High court vide its orders dated 12.11.24 in WP No 27101 of 2018 has directed the respondents (District Collector, Medchal Malkajgiri, District Panchayat Officer and 7 others) to pass appropriate orders on the representations of the petitioner in accordance with law. The Order copy may be submitted to NCST.
- The Endowments and Revenue Departments may submit the details of the total extent of land in each of the said survey numbers covered under Inam lands situated at Devaryamjil village of Shameerpet Mandal of Medchal Malkajgiri District along with those currently under encroachment.
- The commission proposes to visit the said location shortly hence the details may be submitted to arrive at clarity.

3. Hon'ble Member, National Commission for Scheduled Tribes (NCST) visited Sant Sevalal Mallanna Thanda, Devarayamjil, Medchal Malkajgiri District on 15.9.25 and tour report was forwarded to all concerned authorities on 25.9.2025 for submission of ATR within 30 days from receipt of the Tour Report.

4. TGSPDCL, Operation Circle, Medchal, vide letter dated 15.11.2025 has informed action was initiated for providing basic amenities, particularly electricity, to ST families residing at Sevalal Thanda, Devaryamjal, Shameerpet Mandal. It has been stated that though approval was earlier accorded for release of individual domestic electricity services subject to submission of identity proof, indemnity bond and security deposit, individual connections were stopped due to objections from the Endowment Department and a temporary single-meter supply was provided for common use. The authority has further informed that pursuant to the visit and directions of the Hon'ble Member, National Commission for Scheduled Tribes, dated 15.09.2025 and subsequent directions of the District Collector, requests have been received to provide individual metered connections to ST households. The Superintending Engineer has accordingly sought further instructions to proceed with release of individual electricity services to the ST families as per earlier orders and prescribed conditions.

5. The reply from other agencies were not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 19.12.2025. Accordingly, a Sitting Notice was sent on 09.12.2025. The Collector & District Magistrate, Medchal Malkajgiri vide letter dated 16.12.2025 has sought exemption and deputed RDO, Keesara Division, Medchal Malkajgiri to attend the sitting. There was no response from Municipal Commissioner, Thumkunta Municipality, Tribal Welfare Officer, District- Medchal Malkajgiri and Commissioner, Endowment Department, Govt. of Telangana.

6. In the sitting, the RDO, Keesara Division, Medchal Malkajgiri, representative from TGSPDCL, Hyderabad and petitioners were present. The petitioners has reiterated their earlier submission and requested to provide basic facilities especially Electricity connection.

7. After discussion with the RDO, Keesara Division, Medchal Malkajgiri, representative from TGSPDCL, Hyderabad and petitioners, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.

- a. Temporary provision of individual electricity meters may be made based on the self declaration and indemnity bond.
- b. The petitioners may bear the erection charges and deposit the required amount for erection of the electric poles.
- c. The Endowments and Revenue Departments may submit the details of the total extent of land in each of the said survey numbers covered under Inam lands situated at Devaryamjil village of Shameerpet Mandal of Medchal Malkajgiri District along with those currently under encroachment.
- d. The Commissioner, Endowments Department, District Collector, Medchal-Malkajgiri and Municipal Commissioner, Thumkunta Municipality may attend to the next scheduled date of hearing.
