Minutes of the sitting held under the Chairmanship of Shri Jatotu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Smt. Shashi Prabha Nursing Attendant, RML Hospital, New Delhi regarding Caste-based harassment and mental harassment at workplace.

Smt. Shashi Prabha Tudu, Nursing Attendant, Department – Trauma ICU (Critical Care Medicine), ABVIMS & Dr. RML Hospital, New Delhi—110001, vide her petition dated 12/06/2025 has stated that she is being mentally harassed by Mrs. Poonam Pasrija and Mrs. Surinder Kaur, who are repeatedly preventing her from using the changing room despite permission granted by Dr. Ranvinder Kaur (Director Professor and H.O.D.); she lodged an earlier complaint to the administrative office (E2 Section, E-file No. 25460, complaint No. E2-11021/10/2025 R.M.L.) on 14/05/2025 and another complaint (E-282044/2025) on 29/05/2025 after an incident on 20/05/2025 when Mrs. Surinder kaur reportedly knocked the changing-room door and used an insulting caste-based remark; she also reports that on 21/05/2025 Mrs. Poonam publicly accused her in connection with a missing item (initially alleged "injection fentanyl", later stated as a sandal belonging to Mrs. Pramila), after which the four sister-in-charges were transferred—she requests that the Commission consider the matter and issue a circular to prevent recurrence.

2. NCST vide notice dated 07.10.2025 sought facts and comments from the Director, ABVIMS & Dr. Ram Manohar Lohia Hospital within 30 days from receipt of the Notice. Reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 05.12.2025. Accordingly, a Sitting Notice was sent on 02.12.2025. In the sitting, the petitioner was present but the authority was absent. Hence, the sitting was postponed and re-fixed for 5.1.2026. Accordingly, a sitting was sent on 26.12.2025. The Director, ABVIMS & RML Hospital, New Delhi vide letter dated 5.1.2026 has sought exemption and deputed Addl. Medical Supdt and Administrative Officer to attend the sitting.

3. In the sitting, the Addl. Medical Supdt and Administrative Officer of ABVIMS & RML Hospital and petitioner were present. The petitioner has reiterated her earlier submission and requested for justice. The officers of ABVIMS has provided the copy of letter no. E-II-11021-10-2025-E-II section Dr.RMLH/26 dated 2.1.2026 alongwith minutes of Fact Finding Inquiry Committee. In the letter, it has been informed that a Fact Finding Inquiry Committee was constituted and the meeting was held on 1.1.2026. Thereafter, a Show Cause Notice was issued to the Sister In-charges (Smt. Surender Kaur, Smt. Poonam Pasrija) on 3.1.2026. The reply from the opponents are awaited.

4. After discussion with the officers of ABVIMS & RML Hospital and petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- The management of ABVIMS & RML Hospital is advised to sensitize the staff of the organisation regarding customs and culture of Scheduled Tribes communities.
- An Internal Grievance Committee for redressal of grievances of ST employees may be constituted as advised by NCST in Aug, 2021 (copy enclosed).
- The HoD and Supdt. of the department concerned may be advised to resolve the issue amicably.
- The suitable action may be initiated against the opponent / accused, if the reply is not received within the time frame of the Show Cause Notice issued by the ABVIMS & RML Hospital to them.
