Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Nenavath Ashok Kumar Naik, House No 41g Block No 6 Singareni Colony Saidabad, Hyderabad, Telangana regarding land related atrocities committed on them by the Caste Hindus.

Shri Nenavath Ashok Kumar Naik and Shri Ratlavath Ravi, residents of Telangana, vide their complaint dated 04.12.2025 have alleged illegal interference in their peaceful possession of plots bearing Nos. 113, 114, 115, 116, 135, 136, 137 and 138 situated at Ragannaguda Hamlet, Turka Yamjal Village, Ranga Reddy District, purchased through registered sale deeds executed in 2025, along with caste-based abuse, threats and harassment by certain private individuals including a former Corporator. They have stated that the accused persons insulted their ST (Lambada) identity, attempted to fabricate false documents, filed false cases using political influence and carried out illegal constructions without permission, despite the fact that earlier civil suit O.S. No. 2447/2011 and appeal A.S. No. 364/2016 were dismissed by the Hon'ble XI Addl. District Judge, L.B. Nagar, holding that the accused have no right or title over the land. The petitioners further submitted that despite repeated complaints to the SHO, Adibatla Police Station, Rachakonda Commissionerate, and the Municipal Commissioner/Town Planner, Turka Yamjal, no effective action has been taken and instead false counter-cases were filed against them. Alleging violations under relevant provisions of the SC/ST (Prevention of Atrocities) Act, 1989, the petitioners have sought intervention of the Commission for inquiry, stoppage of illegal construction, registration of FIR, police protection and action against erring officials.

2. NCST vide notice dated 10.12.2025 sought facts and comments from the District Collector & Magistrate District-Rangareddy and Commissioner, Turkyamajal Municipality, District-Rangareddy within 15 days. The reply was not received, hence, NCST decided to discuss the issue with the authorities and the petitioner on 05.01.2026. Accordingly, a Sitting Notice was sent on 26.12.2025. The Collector & Magistrate District-Rangareddy vide letter dated 3.1.2026 has sought exemption and deputed C1/NCST/2994/2025 dated 3.1.2026 has sought exemption and deputed RDO, Ibrahimpatnam Division to attend the sitting.

3. In the sitting, RDO, Ibrahimpatnam Division, representative of Greater Hyderabad Municipal Corporation and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The RDO, Ibrahimpatnam Division has provided the letter bearing no. C1/NCST/3666/2025 dated Jan, 2026 which contains the action taken by the District Administration. In the letter, the report of Dy. Commissioner, Adibatla, GHMC Circle 15, Shamsabad Zone were reported. On the basis of the report it has been informed that the matter is Civil in nature. The representative of GHMC has provided the letter bearing no. 01/DC/AC-15/GHMC/2026 dated 2.1.2026 of Dy. Commissioner, Adibatla, GHMC Circle 15, Shamsabad Zone. In the report it has been mentioned that the provisional permission for building order has been given in favor of Smt. Maddi Radhika and others, these names does not figure in the complaint filed by the petitioner. However, the matter is Civil in nature, hence, appropriate civil courts may be approached by the petitioner.



4. After discussion with the authority and petitioner, the following observations/recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- As the orders of the DPO and Municipal Commissioner are contradictory and the Municipal Commissioner has given permission to the opponent without any intimation to the petitioner when the dispute is unsettled, the work on the disputed site may be stopped immediately.
- A joint inspection may be conducted by the concerned RDO and Municipal Authorities to assess the ground realities.
- As the petitioner has alleged that the accused have threatened them, necessary action taken so far on the complaints of the petitioner in Adibatla Police Station may be submitted to NCST by the CP, Rachakonda.
- District Collector, Rangareddy, Municipal Commissioner, Turkyamajal and CP Rachakonda may attend to the next scheduled date of hearing.
