Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Dharavath Hathiram, Vinayaka Thanda, Mangal Colony, Mahabubabad, Telangana State regarding encroachment of tribal by the caste hindus.

Dharavath Hathiram, a resident of Vinayaka Thanda, Mangal Colony, Mahabubabad, Telangana State, submitted a representation stating that in Mahabubabad Municipality Centre, Mahabubabad Revenue Suburb, Survey No. 551, the government land has been cultivated by Scheduled Tribe Lambadi people for the last 70 years. He stated that his grandfather had purchased two acres of land from the Scheduled Tribe residents and cultivated it for a few years. Subsequently, after Mahabubabad developed into a municipality and later a district, the MLA Government Camp Office was constructed in the said area, and his land is situated adjacent to it. He further alleged that one Gadde Ravi, along with his followers, has encroached upon the said land, constructed houses, sold portions of it, and is presently constructing a petrol pump and other illegal structures. The petitioner has requested restoration of the land.

2. NCST issued notice to the Collector & District Magistrate, District- Mahabubabad and Superintendent of Police, District-Mahabubabad on 18.09.2025 for seeking facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 07.01.2026. Accordingly, a Sitting Notice was sent on 26.12.2025. The Addl. Collector, District-Mahabubabad vide letter dated 3.1.2026 has deputed Tehsildar, Mahabubabad to attend the sitting. The SP, District-Mahabubabad vide letter dated 29.12.2025 and deputed SDPO to attend the sitting.

3. In the sitting, the above officers and petitioner were present. The petitioner has reiterated their submission and requested for justice. The SDPO, District-Mahabubabad provided the letter bearing no. 31/D6/DCRB-MHBD/2025 dated 5.1.2026 of Supdt. of Police, District-Mahabubabad. In the letter, facts and comments and action taken by the Police Department has been discussed. In the concluding para of the letter, it has been mentioned that the alleged place mentioned by the petitioner does not fall under survey No. 551 and it falls under survey no. 429 of Mahabubabad Revenue Village, as per the report of Tehsildar, Mahabubabad, no title has been issued or recorded in the name of the petitioner's grandfather Daravath Bicha.

4. After discussion with the officers District Administration of Mahabubabad and petitioner, the following observations/recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- There appears to be an ambiguity as the petitioners are claiming the said land falls in survey number 551 and authority contradicts that it is a patta land falling in other survey number.
- As the allegation is against the collusion of the Revenue authorities, CCLA may facilitate conduct of the detailed survey of Government lands in Sy.Numbers 551, 287 and submit the details of original land in the said survey numbers, allocations legally made so far and balance vacant lands available along with the unauthorised encroachments.
- The said survey may be conducted impartially with a special team not involving the District Revenue authorities with adequate police protection in a month and the report may be submitted to NCST for further necessary examination.
