Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Dharamsoth Mangilal, Village Bhupathipeta Komatipally Thanda Gudur Mandal Mahabubabad District, Telangana State regarding atrocities committed on them by Shri Aavula Ashok, S/o Yakanna of Bhupathipeta Village.

Shri Dharamsoth Mangilal, resident of Komatipalli Thanda, H/o Bhupathipeta, vide his petition dated 19-08-2025, has submitted that he and his mother Smt. Dharamsoth Maali were subjected to caste-based abuse and derogatory behaviour by Aavula Ashok s/o Yakanna in connection with a dispute over their ancestral land. He has stated that during mediation by elders, the said individual interfered unjustly, accepted a deposit of ₹60,000, misappropriated ₹30,000, and failed to ensure a fair settlement. When questioned about his conduct, the accused allegedly abused the petitioner and his mother using caste-based slurs and behaved aggressively. The petitioner has requested registration of an ST Atrocity case against the accused and intervention to secure justice regarding their ancestral land.

2. NCST issued notice to the Collector & District Magistrate, District-Mahabubabad and Superintendent of Police, District-Mahabubabad on 18.09.2025 for seeking facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 07.01.2026. Accordingly, a Sitting Notice was sent on 26.12.2025. The Addl. Collector, District-Mahabubabad vide letter dated 3.1.2026 has deputed Tehsildar, Mahabubabad to attend the sitting. The SP, District-Mahabubabad vide letter dated 29.12.2025 has deputed SDPO to attend the sitting.

3. In the sitting, the above officers were present and petitioner joined via phone. The petitioner has reiterated their submission and requested for justice. The officers of District Administration informed that the matter is being enquired.

4. After discussion with the officers District Administration of Mahabubabad and petitioner, the following observations/ recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- The Revenue authorities may cause a detailed enquiry into the claim of the petitioner.
- The police may recover the misappropriated amount and hand it over to the petitioner and if the atrocity is proved the case may be booked with relevant sections of the POA Act.
