Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Korra Hanmantu, Assistant Manager (Compulsory Retired), State Bank of India, Suryapet ADB Branch, Telangana regarding Denial of reinstatement to ST employee of SBI.

Shri Korra Hanmantu, Assistant Manager (Compulsory Retired), State Bank of India, Suryapet ADB Branch - a resident of H.No. 19-61, Beside Judge Quarters, Uppununthala Road, Achampet (Village & Mandal), Nagarkurnool District, Telangana. vide his representation dated 22.08.2025 has stated that despite serving since 1996 without adverse remarks, he was compulsorily retired on 14.11.2011 in connection with irregularities in Suryapet ADB Branch, even though no financial loss was caused to the Bank and other similarly placed staff members were not punished. He has requested for reinstatement as Assistant Manager in the State Bank of India.

2. NCST vide notice dated 19.09.2025 sought facts and comments from the Chairman & Managing Director, State Bank of India, Mumbai within 30 days from receipt of the Notice. The State Bank of India vide letter no. HR/IR/3/1226 dated 04.11.2025 has informed that the issue has been examined and found untenable, as during his tenure as Assistant Manager at ADB Suryapet Branch between 20.07.2009 to 23.04.2010 he committed serious financial irregularities by unauthorisedly debiting Agricultural Cash Credit accounts and crediting amounts to third-party and his own OD account for pecuniary gain. the Disciplinary Authority recommended compulsory retirement vide order dated 17.08.2011 and thereafter, a personal hearing was granted on 12.11.2011. Appointing Authority imposed the penalty of compulsory retirement vide order dated 14.11.2011. The Appellate Authority, vide order dated 12.07.2012 upheld the punishment and the Reviewing Authority/Managing Director also rejected the review petition, observing breach of trust by the petitioner. The Bank has further stated that the entire disciplinary process was fair, transparent, conducted as per service regulations, involved multiple authorities, revealed no discrimination, and no lapses were found on the part of other staff; hence, the Commission has been requested to dismiss the representation. This was sent to the petitioner vide NCST letter dated 01.12.2025.

3. The petitioner was not satisfied with the reply, hence, NCST decided to discuss the issue with the authority and the petitioner on 05.01.2026. Accordingly, a Sitting Notice was sent on 29.12.2025.




4. In the sitting, the Chief General Manager along with other officers of SBI and petitioner were present. The petitioner has reiterated his earlier submission and requested the Chief General Manager, SBI has also reiterated the facts and comments submitted by SBI vide its letter dated 4.11.2025.

5. After discussion with the officers of SBI and petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- The management of SBI is advised to re-examine the case on humanitarian grounds.
