Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Sapavat Balu Nayak, Manchal Mandal, RR District Telangana regarding restoration of tribal land.

Shri Sapavat Ravinder and Shri Sapavat Pandu, residents of Bodakonda Revenue Village, Manchal Mandal, Ranga Reddy District, vide their representation dated 25-07-2025 has alleged that agricultural lands measuring Ac. 90-00 situated in Survey Nos. 181, 182, 183, 184, 194 and 195 of Bodakonda Village have been illegally encroached upon by private individuals. They have stated that ST farmers have been cultivating the said lands for nearly 80 years, much prior to independence, after clearing forest land for livelihood. It is alleged that in the year 2023, the encroachers, with police support, intimidated ST farmers, lodged false cases, and fenced large extents of their lands. The petitioners have requested intervention of the Commission for restoration of the encroached lands and protection of the ancestral rights of ST farmers.

2. The Commission issued notice to the District Collector & Magistrate District-Rangareddy and Deputy Commissioner of Police, District:-Shamshabad vide NCST letter dated 02.09.2025 seeking facts and comments within 30 days. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 05.01.2026. Accordingly, a Sitting Notice was sent on 26.12.2025. The District Collector and Magistrate, Rangareddy vide letter no. C1/NCST/2994/2025 dated 3.1.2026 has sought exemption and deputed RDO, Ibrahimpatnam Division to attend the sitting.

3. In the sitting, RDO, Ibrahimpatnam Division was present and the petitioner joined via online. The RDO, Ibrahimpatnam Division has provided the letter bearing no. C1/NCST/2994/2025 dated Jan, 2026 which contains the action taken by the District Administration. In the letter, it has been informed that a WP. No. 33175 of 2025 was filed before the Hon'ble High Court, Telangana. As per directions of the Hon'ble High Court of Telangana, Ibrahimpatnam Division has issue notice to all concerned before the RDO, Ibrahimpatnam alongwith explanation and documentary evidence. But they did not submit any documents and sought 15 days time to submit the same. Hence, the enquiry could not conducted. Therefore, NCST is requested to grant three months time for submission of detailed report.


4. After discussion with the RDO, Ibrahimpatnam Division and petitioner, the following observations/ recommendations were made and action taken report may be submitted to NCST within (3) Months from receipt of the minutes.

- The petitioner is advised to consult the RDO and submit all the documentary evidences in support of his claim.
- The Revenue authorities may conclude the enquiry at the earliest and submit a detailed report to NCST for further examination.
