Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Bhukya Alwar Swamy, Nadigadda Thanda Miyapur Sherilingampally, Ranga Reddy District of Telangana State regarding harassment by CRPF.

Shri Bhukya Alwar Swamy, Nadigadda Thanda Miyapur Sherilingampally has stated that around 5,000 tribal residents of Nadigadda Tanda under Miyapur village, Sherilingampally Mandal, Ranga Reddy District (Telangana) have been residing there since before independence and were provided with basic facilities by the Government, including roads, drainage, water, electricity and a hospital. However, since 2016, a CRPF camp has been set up at the entrance of the Tanda and CRPF personnel are allegedly harassing the residents, claiming the land belongs to the Central Government. They are said to be intimidating the Tribal people, restricting basic movement and supplies and threatening eviction, causing severe mental distress. The petitioner has requested for justice to stop the harassment and to ensure a compound wall is built to prevent CRPF intrusion.

2. In this matter a sitting was held on 25.07.2025. Further, a visit was undertaken (by Hon'ble Member, NCST, Shri J. Hussain) on 15.9.2025 of the said village. The following recommendations were made and report was forwarded to all concerned on 25.9.2025 with request to furnish the ATR from receipt of the Visit Report.

- a). A scientific survey may be taken up in 15 days to examine the actual land encroached and fixing the boundary so as to avoid further encroachments.
- b). Detailed enumeration may be done and the Number of families residing in the colony, along with other demographic details of school going children, drop outs, job less youth, pregnant and lactating women, old age population eligible for pensions etc may be made in a months time. Income sources of the families and BPL Families and ownership of land elsewhere may also be captured.
- c). A strong fence may be constructed with the funds available under CDP of MLA or funds available with the District Collector.
- d). All the sanctioned road works may be commenced immediately.
- e). The District collector may propose the Housing requirement for Houseless poor in the colony under the Government Housing scheme.
- f). A permanent structure may be built for the Basti Dawakana which is already existing.
- g). The Anganwadi centre is in Miyapur which is difficult to be accessed by the children and pregnant women. Hence Anganwadi centre may be allotted to the colony.
- h). The basic requirements like Primary school, community hall, Vaikuntadhamam/Grave yard may be created with adequate space.
- i). With regard to the Drainage facilities, the alignment of the Drainage canal may be changed and constructed immediately. the community soak pit may be constructed and Drainage channels may be dug immediately under the supervision of the Municipal Commissioner in 15 days.
- j). Assessment of Drinking water requirement may be taken up by the Rural water supply Department in 15 days and necessary pipelines for household water supply may be taken up as per the feasibility.
- k). The CRPF and the public may treat each other with mutual respect.
- l). Proposals may be moved by the District Collector and State Government for a NOC from the Custodian of Enemy Property, Ministry of Home for issuance of patta certificates and ownership rights to BPL families.
