Minutes of the sitting held under the chairmanship of Dr. Asha Lakra, Hon'ble Member, NCST on 24.12.2025 at 12:30 PM at Lok Nayak Bhawan, Khan Market, New Delhi, regarding Request for promotion to the post of PGT (Hindi) against Schedule Tribe quota- complaint dated 22.04.2025 of Shri Avdhesh Kumar Meena, TGT (Hindi), Navyug School, Lodhi Road, New Delhi under the Directorate of Navyug School Education Society (NSES/NDMC).

Shri Avdhesh Kumar Meena, TGT (Hindi), Navyug School, Lodhi Road, New Delhi, under NSES/NDMC, has requested to the National Commission For Scheduled Tribes for promotion to the post of PGT (Hindi) against the Scheduled Tribe quota. He was regularly promoted from PRT (Hindi) to TGT (Hindi) in 2016 and has an unblemished service record. The applicant contends that despite representations made in December 2021 and November 2023, no response was received regarding vacant posts or his promotional prospects. He alleges improper application of the reservation policy, including promotion of two ST candidates in 2016 to PGT posts against the general category, and arbitrary reduction of five ST backlog vacancies (shown since 2010–11) to zero in 2021 by applying a new roster. He further claims that three posts of PGT (Hindi) are currently vacant and that the new roster was applied without first clearing backlog vacancies. According to him, promotions should have been made cadre-wise under the old roster instead of subject-wise under the new roster, and that promotions made in 2021 violated the prescribed cadre-wise policy.

2. The NCST vide notice dated 22.09.2025 had referred the matter to the Director Navyug School Educational Society (NSES) N.D.M.C, Palika Kendra, New Delhi and requested to furnish a factual report within 15 days from the receipt of the notice.

3. Pursuant to the matter, a reply dated 13.11.2025 was received from the Joint Director, Navyug School Educational Society (NSES). It was stated that the promotions to the posts of PGT (Physics) and PGT (Computer Science) made in 2016 pertained to Scheduled Tribe candidates and were effected through duly constituted DPCs as per applicable rules, and were unrelated to the applicant, who was promoted as TGT (Hindi) in September 2016.


4. It was further submitted that prior to 17.09.2020, PGT (Hindi) posts were filled 100% by promotion, which was revised to 25% Direct Recruitment and 75% Departmental Promotion after notification of the
