Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Banoth Prabhas, Megiya Thanda village, Dantalapally Mandal of Mahabubabad District of Telangana State regarding atrocities committed on him by the Railway authorities of Dornakal Railway station, -Station Manager, Inspector of works, Assistant Divisional Engineer.

Shri Banoth Prabhas Nayak, resident of Megiya Thanda, Dantalapalli Mandal, Mahabubabad District, vide his representation dated 01-11-2025 has stated that he owns about Ac. 2.00 land in Survey No. 17 near Dornakal town, which he lawfully purchased and developed by investing around Rs. 50 lakhs. Due to heavy rains and flooding on 29-10-2025, railway authorities allegedly diverted flood water through his land by damaging the railway boundary and illegally excavating a large canal of about 30 feet width and 400 feet length, resulting in loss of nearly 10 guntas of land and financial loss of about Rs. 1 crore, without his consent. He has further alleged that when he contacted railway officials including the Station Manager, Inspector of Works and Assistant Divisional Engineer over phone to seek an explanation, he was abused, threatened and subjected to caste-based slurs, being addressed in derogatory terms referring to his ST community and was also threatened with dire consequences. Hence, do the justice.

2. NCST issued notice to the General Manager, South Central Railway on 04.12.2025 for seeking facts and comments within 15 days from receipt of the Notice. The Reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 06.01.2026. Accordingly, a Sitting Notice was sent on 29.12.2025. The General Manager, South Central Railway, Secunderabad vide letter no. 529009/2026 dated 6.1.2026 has requested for exemption and deputed Sr. Divisional Engineer, South Secunderabad Division to attend the sitting.

3. In the sitting, the Sr. Divisional Engineer, South Secunderabad Division along with other officers of South Central Railway and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The officers of South Central Railway has provided the copy of correspondence made by the South Central Railway with the Municipal Commissioner, Dornakal and Mandal Revenue Officer, Dornakal alongwith photographs of the respective sites. It was informed that the complainant has unauthorisedly and illegally blocked the existing railway drainage canal (railway naala) by dumping soil and forming private ventures over the same. The said drain is the only available and officially recorded outlet for discharge of storm water from Dornakal Railway Station, Yard, and Railway Colony. The complainant's actions were carried out without any permission or lawful authority and in complete violation of established norms.

4. After discussion with the officers of South Central Railway and petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- The South Central Railway and District Collector, Mahabubabad are advised to facilitate to conduct a survey of the said land for demarcation of boundaries of Railways and petitioner.
- The petitioner is also advised to meet the concerned Revenue authorities of the Mahabubabad District and Mandal Revenue Officer, Dornakal regarding demarcation of his land. The Revenue authorities are advised to resolve the issue within a stipulated time.
- The District Collector, Mahabubabad and the Revenue authorities may finalise the amount of compensation if the petitioner is eligible for it and immediately communicate it to South Central Railways for further necessary action.
- District Collector, Mahabubabad may submit a detailed report in the matter.
