

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Jakka Satyanarayana, S/o Venkateswarao and others of R/o Mondivarre Village, Dammapeta Mandal, Bhadradri Kothagudem District, Telangana state regarding land disputes.

Shri Jakka Satyanarayana, S/o Venkateswarao and about 300 ST residents of R/o Mondivarre Village, Dammapeta Mandal, Bhadradri Kothagudem District, Telangana state submitted a representation dated 27.09.2024 stating that they have been in peaceful possession and cultivation of 270 acres in Survey Nos. 454/81-103 and 484 for the past 60-70 years, spanning three generations, and many among them have also received title deeds and passbooks earlier. They claim that an individual named Dinkar, who had once been given a mere firewood-cutting receipt decades ago, had no land rights, yet his son-in-law Anil Dev Kantepudi is now allegedly claiming ownership through a GPA and threatening the ST cultivators with support from some officials. They further state that the land falls under Agency/1 of 7U Act and that, under the Forest Rights Act, 2005, they are entitled to recognition of long-standing cultivation. The petitioners request the Commission to direct the police, revenue, electricity, forest and ITDA authorities to take action against the respondents, provide police protection, and issue pattadar passbooks, title deeds and electricity connections for their borewells.

2. NCST issued notice to the Collector & District Magistrate, District-Bhadradri Kothagudem and the Superintendent of Police District-Bhadradri Kothagudem on 24.01.2025 for seeking facts and comments within 30 days from receipt of the Notice.

3. The Superintendent of Police, Bhadradri Kothagudem District, vide letter no. 05/C-1/DCRB-BKGM/2025 dated 19.03.2025, has informed the Commission that the petitioner Sri Jakka Satyanarayana and about 300 ST persons claimed cultivation over nearly 270 acres in Sy. No. 454/81 to 103 of Mondivarre village for the past 70 years and alleged threats from private respondents connected to one Dinkar, a non-ST, who was claiming rights through a GPA. The SP stated that except the allegation of threats, all other issues relate to Revenue and other departments. The enquiry conducted by the SDPO Palvancha found no evidence of threats by the respondents as alleged. The petitioners were advised to approach the concerned Revenue authorities, who will decide the ownership of the land. It was concluded that no further action is required from the Police Department at present.

4. The Reply was not satisfactory, hence, it was decided to discuss the issue with the authority and the petitioner on 06.01.2026. Accordingly, a Sitting Notice was sent on 26.12.2025.

5. In the sitting, SDPO, Palvancha was present and petitioner joined through phone. There was no communication from District Collector, Bhadradri Kothagudem.


6. After discussion with the SDPO, Palvancha and petitioner, the following observations/recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.

- It is observed that a WP 28562/2009 is pending before the Hon'ble High Court of Telangana in this matter. The Revenue authorities may expedite the issue on behalf of the STs.
- Basic infrastructure of Electrification lines and 3 phase electricity may be provided for the undisputed land in which the STs are cultivating the land.
- The District Collector Bhadradri Kothagudem and PO, ITDA Bhadrachalam may attend to the next scheduled date of hearing.
