Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Rajkumar Gugulothu, Proprietor, M/s GSR Enterprises.

Shri Rajkumar Gugulothu, Proprietor, M/s GSR Enterprises, vide his representation has stated that he has been working as an electrical subcontractor for M/s FORZA Interior Pvt. Ltd. since November 2023 for projects at Bharat Biotech and IKP Corporate Office, Hyderabad, but an amount of ₹26,80,354/- relating to IKP project under Work Order dated 01.04.2024 has been pending since October 2024. He has alleged that despite repeated follow-ups, the company owner has avoided payment and used threatening language, causing severe financial hardship, and has sought the Commission's intervention to secure release of dues and prevent harassment of an ST entrepreneur.

2. The Commission issued notice to the Commissioner of Police, Cyberabad vide NCST letter dated 12.08.2025 seeking facts and comments within 30 days.

3. Reply has not been received hence the Commission has decided to discuss the issue with the authority and the petitioner on 05.03.2026. Accordingly, a Sitting Notice was sent on 25.02.2026.

4. The petitioner has attended for the hearing. The authority is represented by the ACP.

5. The petitioner has reiterated his grievance and stated that though after a lapse of considerable time of complaint he has not got any relief.

6. The authority has stated that the notices are served to the IKP for the related workorders, invoices, purchase orders and engineers attements etc and the investigation is in progress.

7. After hearing to the petitioner and authority the following observations/recommendations ar emade and the ATR may be submitted in 15 days from the receipt of Minutes.


a. The copies of Notices /correspondence of Police Department with the relevant parties may be submitted to NCST.

b. The investigation may be concluded at the earliest in 15 days for necessary action of the pending payment to the ST enterprenuer by the concerned.
