Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Gugulothu Naveen and Banothu Naresh regarding correction of pattadar passbooks.

**Date of the Sitting: 18/02/2026, 02:20PM**

Shri Gugulothu Naveen and Banothu Naresh, residents of Meettya Thanda Gram Panchayat, Mahabubabad District, vide their petition dated 06/09/2025 has submitted that ST farmers were issued Podu land pattas but due to survey officials' errors, names and photos were wrongly entered in passbooks which were submitted to the MPDO, Nellikuduru and forwarded to the District Collector Office, Mahabubabad (Tribal Welfare Department) for correction; however, even after two years the corrected passbooks have not been returned despite repeated representations, and the petitioners have requested the Commission to direct the concerned authorities to correct and return the patta passbooks at the earliest.

2. The Commission issued notice to the Collector & District Magistrate, District:- Mahabubabad vide NCST letter dated 18.09.2025 seeking facts and comments within 15 days.

3. The Commission decided to discuss the issue with the authority and the petitioner on 18.02.2026. Accordingly, a Sitting Notice was sent on 06.02.2026.

4. The District Tribal Development Officer is present on behalf of the District Collector. The petitioner has joined over phone.

5. The petitioner has reiterated the grievance. The DTDO has informed that as the online portal of Mee-seva module of FRA has been stopped, the provision of editing of the passbooks does not exist and the Commissioner of Tribal welfare has been addressed in this regard for necessary action.

6. After hearing to the petitioner and authorities, the following observations/recommendations are made and the Action Taken report may be submitted in 30 days from the receipt of the Minutes-

a. The Commissioner of Tribal welfare may address the District Collectors of all the Districts to identify such cases requiring the corrections of errors in podu pass books and a one time option may be given in the portal for correcting the same as the ST farmers with FRA title deeds are losing the Government support of Rythubarosa etc year after year due to the pending corrections of spelling mistakes, photos etc.


b. If necessary the issue may be placed in the State level Monitoring committee and an action plan may be made for a time bound completion of such exercise in coordination with the DLCs in the Districts.
