Minutes of sitting held in the Commission on 01/02/2018 at 12:00 Noon under the Chairmanship of Shri Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri Ashish Anan, Dy. SP(u/s), UT of Daman & Diu, R/o E-Type Quarter, Near Collectorate, Dholar, Moti Daman - 396220 regarding complaint against Mrs. Meghna Yadav, IPS, SP/Daman and other Police Officials of DD&DNH Police under the PoA Act, 1989.

Representation dated 19/07/2017 received from Shri Ashish Anan, Dy. SP(u/s), UT of Daman & Diu, R/o E-Type Quarter, Near Collectorate, Dholar, Moti Daman - 396220 regarding complaint against Mrs. Meghna Yadav, IPS, SP/Daman and other Police Officials of DD&DNH Police under the PoA Act, 1989.

The matter was taken up with the Administrator, UT of Daman & Diu vide this Commission's letter dated 23/10/2017. In this regard no reply has been received from the above said authorities. Therefore, Shri Nand Kumar Sai, Hon'ble Chairperson, NCST has fixed a sitting with the Administrator and Deputy Inspector General of Police, UT of Daman and Diu on 01/02/2018 at 12:00 Noon. Accordingly, the sitting notice has been issued.

Shri Ravinder Kumar, Deputy SP, Daman appeared before the Commission on the day of sitting and submitted a report dated 29/01/2018 of DIG of Police, UT of Daman & Diu and Dadra & Nagar Haveli in the matter.

It has been observed by the Commission that the complaint is against an IPS Officer namely Smt. Meghna Yadav, SP / Daman by Shri Ashish Anan, Dy. SP, Daman on 04/11/2016 in Nani Daman Police Station under provisions of SC/ST (Prevention of Atrocities) Act, 1989. Accordingly, the Commission decided to refer the matter to the Ministry of Home Affairs with request to conduct an independent inquiry into the allegation made by Shri Ashish Anan in his complaint dated 04/11/2016 by any IPS Officer of the rank of Inspector General of Police or above and submit the report to the National Commission for Scheduled Tribes alongwith considered view of the Ministry of Home Affairs within a period of 3 Months.
