It is requested that action taken/to be taken on the recommendations of the Commission in the matter may please be intimated to the NCST at an early date.



PROCEEDINGS OF SITTING HELD ON 06.03.2018 AT 12.00 NOON CHAIRED BY SHRI NAND KUMAR SAI, HON'BLE CHAIRPERSON, NCST ON THE REPRESENTATION DATED 07.02.2017 OF SHRI BALA SAHEB ANAND PAWAR, VILLAGE AND POST – JEAUR (NEAR POND OF PIMPAL GAON) TEHSIL AND DISTRICT - AHMAD NAGAR (MAHARASHTRA) REGARDING ALLOTMENT OF GOVERNMENT LAND IN THE NAME OF NEAR ABOUT 250 SCHEDULED TRIBES BELONGING TO BHIL GROUP WHICH IS UNDER THE POSSESSION OF SCHEDULED TRIBES FROM THE BRITISH PERIOD.

Date of Sitting: 06.03.2018

Shri Balasaheb Anand Pawar, Village and Post – Jeaur (near pond of Pimpal Gaon) Tehsil and District - Ahmad Nagar (Maharashtra) vide representation dated 07.02.2017 has stated that the near about 250 families of Bhil group of Scheduled Tribes residing in the village & Post Jeaur (B) (near pond of Pimpal Gaon), Tehsil and District - Ahmad Nagar during the British period near about 2000 Acre Government land. The Scheduled Tribes families are conducting agriculture on the said land during the British period. The Scheduled Tribes are also undertaking fishing on this pond.

2. In this matter, a Sitting was held on 23.01.2018 at 3.00 P.M. under the Chairmanship of Shri Nand Kumar Sai, Hon'ble Chairperson, NCST. In the Sitting none of the Senior officers reached for discussion. The District Deputy Collector, Ahmednagar deputed Sub-Divisional Officer, Nagar Division, Ahmednagar, the Deputy Secretary, Tribal Development Department, Govt. of Maharashtra had deputed Project Officer, ITDP, Rajur and the Superintendent of Police, Ahmednagar District had informed that the subject matter of the representation solely under the purview of Revenue Department under the District Collector, Ahmednagar and requested for exemption for appearance in the person in the Sitting. Hon'ble Chairperson took the serious views in this issue and fixed another Sitting for 06.03.2018 with Principal Secretary, Revenue Department, Govt. of Maharashtra, Collector and District Magistrate, District Ahmednagar and Commission Maha Nagarpalika, Ahmednagar.

The Principal Secretary, Revenue Department, Govt. of Maharashtra, Mumbai appeared in person, the Collector and District Magistrate, Ahmednagar deputed Additional Collector and Commissioner, Maha Nagarpalika, Ahmed Nagar deputed Additional Commissioner, Maha Nagarpalika to attend the Sitting held on 06.03.2018.
- 4. Hon'ble Chairperson asked petitioner to submit the facts/grievance and the status of implementation of the suggestions made by the NCST in the Sitting held on 23.01.2018. Petitioner stated that there is no construction but builders are taking the sand/soil from said area without fear. As and when asked to stop digging sand/soil, they started quarrelling, abusing and threatened for life. Other petitioners (including male and female), who were also present in the Sitting stated that they are landless and depend upon the said land (which is under the control of Maha Nagarpalika of Ahmednagar) for agriculture and fishing for livelihood. Petitioner(s) demanded for allotment of land in their name so that they can peacefully spend their life by agriculture and fishing.
- 5. Hon'ble Chairperson asked the Principal Secretary, Revenue Department, Government of Maharashtra and Additional Collector, Ahmednagar to explain the facts. The Additional Collector explained that there is no construction but only demarcation in that area. The said land was allotted to the City Municipality of Ahmednagar in 1913. The Principal Secretary, Revenue Department had also supported the facts presented by Additional Collector, Ahmednagar.
- 6. The Hon'ble Chairperson asked the officers of the Govt. of Maharashtra as the said land was allotted to City Municipality, Ahmednagar long back, then why petitioners had not been dislocated. It shows the petitioner are still in possession on the land. Principal Secretary, Revenue Department suggested that a survey is required to be carried out for assessing the situation. The Divisional Commissioner, Nashik, who is the Revenue Head in the Nashik Division should be nominated for undertaking survey work in the said land.
- 7. Accordingly, Hon'ble Chairperson recommended that a fresh survey for assessing the date of physical possession of petitioner(s) (Scheduled Tribes families of Jeaur, Malvi Pimpalgaon Talav, Village & Post, Jeaur) on this land should be carried out by the Divisional Commissioner, Nashik within 3 months from receipt of proceedings of the Sitting. After that NCST will take up the matter with the State Govt. of Maharashtra for appropriate action.
