petitioner given representation dated 15.12.2015 to the Hon'ble Vice-

Chairperson for reinstatement into service. The matter was taken up with the

CMD, Union Bank of India vide NCST letter dated 31.12.2015 and comments and

reasons called and why dismissal was done when the case was pending in the

Commission.

Hon'ble Vice-Chairperson fixed a Sitting on 07.01.2016 to discuss the

matter with CMD, Union Bank of India in the case as no positive action was

taken in the matter.

The CMD, Union Bank of India sought exemption vide their letter dated

06.01.2016 due to his pre-occupation with the visit of Parliamentary Committee

meetings.
