Sub:- Minutes of the Sitting held on 07.06.2018 at 12.00 Noon under the Chairmanship of Hon'ble Chairperson, NCST regarding promotion to the post of Junior Time Scale(JTS) of Indian Statistical Service(ISS) against 3 backlog vacancies of year 1997-98 for ST category from retrospective date in the case of Shri Jag Ram Meena, Deputy Director, NSSO(FOD), Jaipur, Rajasthan including Pay fixation at JTS Grade.

A representation dated 17.08.2016 of Shri Jag Ram Meena, Deputy Director, NSSO (FOD), Jaipur, Rajasthan had been received in National Commission for Scheduled Tribes on 19.8.2016 regarding promotion to the post of Junior Time Scale (JTS) of Indian Statistical Service (ISS) against backlog vacancies for the year 1997-98 for ST category.

- 2. The matter was taken up with the Ministry of Statistics and Programme Implementation, Sardar Patel Bhawan, New Delhi vide this Commission's letter dated 24.08.2016. In response to this, Ministry of Statistics and Programme implementation provided the comments vide their letter dated 30.09.2016 and the same was forwarded to the petitioner for information vide this Commission's letter of even no. dated 10.10.2016. Shri Meena was not satisfied with the comments of the Ministry.
- 3. On request of Shri Meena two sittings were already held in the Commission on 09.11.2016 and on 17.08.2017. Another sitting was held in the Commission on 07.06.2018 at 12.00 Noon under the Chairmanship of Hon'ble Chairperson, NCST. Summons were issued for personal appearance of Secretary, Ministry of Statistics and Programme Implementation.
- 4. The issue raised by the petitioner was discussed in detail. The officials from the Ministry informed that since the eligibility list on the basis of which the recommendations were made by review DPC held on 18.10.2010 has undergone changes, there is a need to hold Review of Review DPC in respect of the officers mentioned in para 3 above in terms of instructions/guidelines contained in the DoPT's O.M. dated 10.04.1989. Thereafter, with the approval of competent authority a proposal for review of review DPC dated 18.10.2010 has

नन्द कुमार साय/Nand Kumar Sai अध्यव/Chairperson राष्ट्रीय अनुसूचित जनजाति आयोग National Commission for Scheduled Tribes धारत सरकार/Govt. of India नई दिल्ली/New Delhi been submitted to UPSC and the promotion order dated 13.12.2010 vide which Shri Jag Ram Meena was promoted to JTS of ISS for the vacancy year 2002-03, has been kept in abeyance vide order dated 01.06.2017. In the meantime Shri Meena represented his case in UPSC and vide letter dated 01.02.2018 UPSC has sought the comments of this Ministry which have been communicated vide letter dated 26.02.2018. With regard to the action taken report on the advice of Hon'ble NCST, as contained in the minutes of the meeting held on 17.08.2017, Ministry informed that a self-contained proposal was sent to DoPT for their views/comments on 23.11.2017. The views/comments of DoPT have been received from DoPT. The summary of the comments of DoPT are as under:

"After due verification of records, final eligibility list of JTS of ISS as on 01.01.2002, issued vide OM dated 05.06.2012 and a proposal for review of review DPC dated 18.10.2010 sent to UPSC on 30.05.2017 seems to be in order".

5. The Commission was not satisfied with reply of the Ministry. Hon'ble Chairman decided that the Ministry will provide a copy of all documents relating to backlog vacancies year-wise from 1997-98, Copy of the reference made to DoPT, UPSC and reply received from DoPT & UPSC in this regard. The Chairperson also requested Hon'ble Member Shri H.K. Damor to examine all the papers that will be provided by Ministry and conclude whether there is any truth in the claim of Shri J.R. Meena.
