A representation dated 19.6.2017 was received from Shri C.M. Meena, Senior Investigator, H. No.RZ-81A, Hans Park, West Sagarpur, New Delhi regarding filling up of backlog vacancies for promotion from Junior Investigator to Senior Investigator Grade-1 CSO in the Ministry of Statistics & Programme Implementation, New Delhi.

- 2. The matter was taken up with the Ministry of Statistics and Programme Implementation, Sardar Patel Bhawan, New Delhi vide this Commission's letter dated 27/06/2017. In response to this, the Ministry of Statistics & Programme Implementation intimated this Commission that a similar issue was raised by the petitioner before Hon'ble High Court of Delhi vide WP No.62/2016. The claim was considered by the Hon'ble High Court on merits and pursuant to the judgement of Hon'ble High Court dated 7th February, 2017, a speaking order was issued by the Ministry and the same was sent to this Commission vide their Order No.11024/13/2015-SSS dated 11th May, 2017.
- 3. The comments/reply of the Ministry was sent to the petitioner for information vide this Commission's letter of even no. dated 17.08.2018. The petitioner was not satisfied with the reply of the Ministry. Hence, the sitting was held on <u>02.11.2017</u> under the Chairmanship of Shri H.K. Damor, Hon'ble Member of the Commission for discussion in the matter. As per Ministry of Statistics & Programme Implementation's O.M. dated 01.02.2018, Shri Meena was promoted as Senior Investigator w.e.f. 18.01.2001 on ad-hoc basis and he was regularized w.e.f. 2004 by Order dated 06.03.2009. But Ministry of Statistics & Programme Implementation did not take any action. Shri Meena approached the Commission again. Therefore, a Sitting was again held on 07.06.2018 at 3.00 P.M. under the Chairmanship of the Chairperson for discussion with the Ministry of Statistics and Programme

Implementation. In the Sitting, the Commission desired that if Shri Meena was eligible for ad-hoc-promotion, then he should be eligible for regular promotion, if clear vacancy is available. The Department has informed that since, Shri Meena was promoted on ad-hoc basis he was not considered for promotion on regular basis from the date he was promoted on ad-hoc basis as regular vacancy was not available and he was not eligible for regular promotion.

Gist of discussion/advice

After detailed discussion on the subject the Commission decided that Secretary, Ministry of Statistics and Programme Implementation is to provide to the Commission the following information/papers. Further, Hon'ble Chairperson also, advised the Ministry to reconsider the transfer of Shri C.M. Meena, sympathetically, immediately.

- 1. Total existing vacancies in the Ministry year wise from 1997 to 2004.
- 2. Backlog vacancies of ST employees year wise from 1997 to 2004.
- 3. Roster points of the ST employees year wise from 1997 to 2004.
- 4. Minutes/Details of the DPC held during the year 1998, 2000 and 2001.
- 5. Seniority List year wise from 1997 to 2014.
- 6. Copies of note portion & correspondence in central statistical office.
- 2. Hon'ble Chairman, requested Hon'ble Member Shri H.K. Damor to examine the above papers with the help of an expert in the matter and find out whether there is any merit in the claim of Shri C.M. Meena as early as possible.
- 3. Regarding his transfer, Secretary, Ministry of Statistics and Programme Implementation informed the Commission that the matter will be reconsidered.
