PROCEEDINGS OF SITTING HELD ON 16.07.2018 AT 02.00 P.M CHAIRED BY SMT. MAYA CHINTAMN IVNATE, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SHRI POPAT PUNJABRAO GAGURDE, MOHALLA POST-DHOTRE, TEHSIL-PARNER, DISTRICT- AHMEDNAGAR (MAHARASHTRA) REGARDING ALIENATION OF LAND.

Date of Sitting: 16.07.2018

List of officers present in sitting is Annexed.

The petitioner Popat Punjabrao Gagurde, Mohalla Post Dhotre, Tehsil Parner, District – Ahmednagar (Maharashtra) and others, District Ahmednagar vide his representation dated 17.08.2017 has submitted grievances that the District Administration of Ahmednagar has not given Patta under 7/12 to the 21 ST families who are cultivating the land at Bheel Basti, Village-Dhotre, Tehsil Parner, District Ahmednagar from 1970.

- 2. The ST families has also made several correspondences with the Revenue Department of District Ahmednagar. But no action was taken to grant regular Patta under 7/12 to them. In addition, on intervention of the Commission, the District Administration has conducted Panchnama of the land but thereafter no action taken was made.
- 3. The NCST vide its letter dated 01.11.2017 and 29.06.2018 has sought a report from the District Collector, Ahmednagar, which is not received. Therefore, Shri Maya Chintamn Ivnate has fixed a Sitting with the District Collector, District Ahmednagar (Maharashtra) for discussion in the matter on 16.07.2018 at 2.00 P.M. Accordingly, Sitting notice has been issued.
- 4. Shri Danej G.P., SDM, Parner, District Ahmednagar appeared before the Commission on behalf of the District Collector, Ahmednagar on 16.07.2018. The petitioners are also present on the day of Sitting. Matter discussed in detail. Hon'ble Member asked the petitioner about his grievances. The petitioner appraised to the Commission that he is residing in that area since 1970 along with other Scheduled Tribe families. All the documents are available with him as the proof of residential on

- 5. The Hon'ble Member asked to the SDM, Parner to explain the position of case. He has submitted to the Commission that proper land records are not available with the petitioner. However, there is a procedure to allot Patta. As per the procedure, the petitioners have to approach to the Village Forest Committee/Gram Sabha of their area with supporting documents for regularization/allotment of Patta. Thereafter, the Gram Sabha will submit the proposal to the SDM concerned/District Collector, Ahmednagar for allotment of Patta. After that the Pattas will be given to the applicants. However, the SDM assured that he will be co-operate to the petitioner and will provide details of the Village Forest Committee for applying/providing Patta/ownership right. The grievance of the petitioner will be resolved within four months.
- 6. After heard both side the Commission observed and recommended that:
 - Patta/ownership right should be provided to the petitioner within four months after completion all necessary formality.
 - Action taken report in the matter should be submit to the Commission within 30 days.
