PROCEEDINGS OF SITTING HELD ON 31.07.2018 AT 12.00 NOON CHAIRED BY MISS ANUSUIYA UIKEY, HON'BLE VICE-CHAIRPERSON, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SHRI RAM PRAVESH RAM, SECRETARY, PRESIDENT ALL INDIA SC/ST/BC EMPLOYEES CO-ORDINATION COUNCIL, RANCHI, JHARKHAND, REGARDING EMPLOYMENT IN LIEU OF LAND.

The National Commission for Scheduled Tribes was received a representation dated 29.06.2015 from Shri Ram Pravesh Ram, Secretary, President All India SC/ST/BC Employees Co-ordination Council, Ranchi, Jharkhand regarding denial of employment in lieu of land to Shri Bobby Munda. The petitioner had alleged that the CCL administration had acquired land measuring 5.55 Acre under khata no. – 46- Plot no. 139,142,145,169,513,515 and 516 belonging to forefathers of Shri Bobby Munda (Scheduled Tribe), Village – Tumang, Post Navadih, District – Ranchi for Rohini Project, N.K. Mining region in the year 1986-87. In this connection, the CCL Management did not provide employment to the family members of Shri Bobby Munda, as per the CCL Policy. Shri Bobby Munda had also submitted application for employment in lieu of acquired land. However, the same was not considered and even after passing of about 34 years, his grievances have not been redressed.

- 2. As per procedure, the NCST vide its letter dated 18.09.2015, and reminders dated 10.03.2016, and 15.09.2017, had sought the report from the CMD, CCL. Thereafter, the CCL authority has submitted a report wherein it was reported that after careful scrutiny of application and relevant documents of Shri Bobby Munda, it was observed that the claimed plots (there is a slight error in the claim. The plot no. 145 wrongly written in place of plot no. 143) were acquired in the 86-87 under LA Act vide case no. 1/86-87 and land compensation for an amount of Rs. 1,48,340.78 was also paid to Sri Tetra Pahan and Sri Lahru Pahan by the concerned State Authorities, who are/were the ancestors of Sri Bobby Munda in the year 1991, The claim of Shri Bobby Munda land compensation is not tenable. The Mine (for which the claimed plots were acquired in the year 1986-87) has been abandoned in the year 1989, Shri Munda has made his first claim for employment in the year 2015 that is after 29 years from the year land acquisition, and almost after 25 years the Mine was abandoned / closed. Presently, it is not possible to entertain the claim of Shri Bobby Munda for employment when the mine is already closed.
- 3. Since the Departments report was found to be unsatisfactory. Hence, a Sitting was held on 31.07.2018 in the Commission.
- 4. During the Sitting, the CMD, CCL along with the petitioners appeared before the Commission and thereafter, they made their submissions.

After hearing both sides, the Commission observed that Shri Bobby Munda had already got compensation in lieu of acquired land. However, the employment was denied to him despite submission of requisite documents and application for employment by the CCL authority. The acquired land was belonged to ancestral property of Shri Bobby Munda and after acquisition of land for Rohini Project by CCL, the father of Shri Munda had submitted application for employment in lieu of land to the CCL authority in due time periods. In addition, there was a provision to provide employment to the family member of acquired land having measuring of 2 acres. This rule was not followed in the case of Shri Bobby Munda. The CMD, CCL has also agreed to examine the matter of non consideration of employment application of Shri Bobby Munda's father/near relatives and reasons for rejecting the claim. Therefore, the Commission recommends that the CCL authority should examine Shri Bobby Munda's claim of employment in the light of the application submitted by him or his relatives and should consider to provide employment in any project of the CCL.
