Minutes of sitting held on 30/07/2018 at 12:00 Hours at Circuit House, Gandhinagar (Gujarat) under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Kanchanbhai Shanabhai Vasava, R/o at Ambavadi, Taluk - Dediyapada, District - Narmada (Gujarat) regarding injustice to the Scheduled Tribes in assistance by Milk Co-operatives of Bharuch & Narmada

Representation dated 28/05/2017 received from Shri Kanchanbhai Shanabhai Vasava, R/o at Ambavadi, Taluk - Dediyapada, District - Narmada, Gujarat regarding injustice to the Scheduled Tribes in assistance by Milk Co-operatives of Bharuch & Narmada.

This case was discussed with Registrar Cooperative Society, Gujarat State and the petitioner in the sitting held on 04/10/2017 at NCST, New Delhi under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST. Further, Shri H. C. Vasava, Hon'ble Member, NCST on 02/04/2018 to 04/04/2018 visited the State of Gujarat and discussed this case at spot with the Officers of the related agencies / Departments. The Tour Report was sent to the Managing Director, Gujarat Co-operative Milk Marketing Federation, Anand (Gujarat) and the Registrar Co-operative Societies, Gandhinagar, Gujarat for furnishing the action taken report on the recommendations of the Commission vide NCST's letter No. BVV/2/2017/STGGJ/DELAAL/RU-I dated 24/04/2018. The action taken report was not received.

A sitting was convened on 07/06/2018 at New Delhi by Shri H. C. Vasava, Hon'ble Member, NCST. The Managing Director, Gujarat Co-operative Milk Marketing Federation, Anand (Gujarat) and the Registrar Co-operative Societies, Gandhinagar, Gujarat was absent and Registrar Co-operative Societies had expressed his inability to attend the sitting due to Annual Chintan Shibir organised by the Govt. of Gujarat during 7th to 9th June at Vadodara and deputed Shri A. C. Chaudhary, District Registrar, Cooperative Societies, Bharuch. The representative of Registrar, Co-operative Societies has attended the hearing without action taken report on the tour report (from 02/04/2018 to 04/04/2018 to Gujarat State) of the Hon'ble Member of NCST and also not able to present the action taken by the Department in the matter. It was advised to concerned Department to submit the report on the action taken by them on the tour report of the Hon'ble Member, NCST from 02/04/2018 to 04/04/2018 to Gujarat State within fortnight. After receipt of the action taken report, the Commission will decide the date of next sitting with the Managing Director, Gujarat Co-operative Milk Marketing Federation, Anand (Gujarat) and the Registrar Co-operative Societies, Gandhinagar, Gujarat. The minutes of the sitting was sent on 15/06/2018. The action taken report was not received.

The Hon'ble Member took it as a serious issue and decided to hold a sitting on 30/07/2018 in Circuit House at Gandhinagar. Accordingly, the notice was issued on 20/07/2018 to Additional Chief Secretary, Revenue Department, Govt. of Gujarat, Collector, District – Narmada and Registrar, Co-operative Society, Gujarat State, Gandhinagar to appear in the sitting on 30/07/2018 to discuss the matter. In the sitting, the Secretary (LR), Govt. of Gujarat, Collector, District – Narmada and Registrar, Co-operative Societies and the petitioner were appeared.

The Hon'ble Member asked the petitioner to explain the grievance and action taken by the District – Administration on the issue. The petitioner informed that the action has not been taken by the Cooperative Societies and requested for justice. The Hon'ble Member asked the authorities to explain the action taken by them in the matter and the tour report of the Commission. The Registrar, Co-operative Societies, Gujarat told that action taken report on the tour report will be submitted to the Commission and issue raised by petitioner, if requires, will be re-examined.

After discussions, it was suggested that the point-wise information and action taken / to be taken on the recommendations / suggestions of the Tour Report dated 02/04/2018 to 04/04/2018 of Gujarat State which includes this case should be sent to the NCST within 15 days from the date of sitting. After receipt of the action taken report from the Registrar, Co-operative Societies, Gujarat, the further course of action will be decided by the Commission.
