Respected Sir,

Sub: Illegal directions by the Parliamentary Committee on SC/ST's to Govt./ PSU organizations to hold meetings of grievances committee with SC/ST combine Associations -Reg

Sir, you are well aware that, Govt. of India has separated the ST Commission from the combined commission of SC/STs with a view to safeguard and protect the interest of Scheduled Tribes. Because the coutture, customs, social hairman N (Standards, location, resources and their problems are entirely different from the Scheduled castes.

> But it is unfortunate to bring your kind notice that the Parliamentary committee on SC & STs, under the influence of the existing combine association of SC& ST employees, has given direction to DOPT to advise the Govt / PSU organizations to hold the grievance redressal committee meetings only with the majority association from combined association of SC/STs, which is totally against the spirit of our constitution and also violation of the fundamental rights of tribes. The parliamentary committee has no right to issue such illegal direction to the DOPT.

> We therefore request the Hon'ble Commission to advice the DOPT to issue directions to Govt/PSU organizations to hold meetings of grievance committee with the associations formed separately and exclusively for the welfare of Scheduled Tribes.

> This step of commission will not only save the scheduled Tribes employees from the clutches and domination of Scheduled Caste employees, but also their grievances can be resolved without any bias.
