Minutes of sitting held in the NCST's Headquarters on 28/08/2018 at 1:00 P.M. onwards under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Maheshbhai Veragbhai Patel and Shri Sanjaybhai Radkabhai Halpati, R/o Amli-Gandhigram, Sivassa, Dadra & Nagar Haveli regarding not measuring the land of the Scheduled Tribes by Survey settlement office of Union Territory of Dadra & Nagar Haveli Administration.

Representation dated nil received from Shri Maheshbhai Veragbhai Patel and Shri Sanjaybhai Radkabhai Halpati, R/o Amli - Gandhigram, Sivassa, Dadra & Nagar Haveli regarding not measuring the land of the Scheduled Tribes by Survey settlement office of Union Territory of Dadra & Nagar Haveli Administration. Representation(s) were referred to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments within 30 days from receipt of the letter dated 11/04/2018.

Shri H. C. Vasava, Hon'ble Member discussed issue with Mamlatdar, Silvasa in a sitting held on 24/05/2018 wherein petitioner was absent. In the sitting, Commission recommended that the District Administration, Dadra & Nagar Haveli should re-examined the issues raised by the petitioner(s) and submit the report to the NCST within a month from the receipt of the proceedings of the sitting. Action Taken Report was not received from the District Administration, D&NH. The Hon'ble Member fixed the sitting on 28/08/2018 to discussed the issue with the Administration of Dadra & Nagar Haveli and District Collector, Dadra & Nagar Haveli.

The Residence Deputy Collector(s), Silvasa has deputed Mamlatdar, Silvasa to attend the sitting. The Residence Deputy Collector(s), Silvasa vide letter No. SRV/RTI/2005/SRH/04/2017/167 dated 24/08/2018 informed that matter raised in the representation is a legacy from 1976. There are many similar cases on which a policy decision is warranted with the approval of the competent authority of the Administration. The Hon'ble Member asked the Mamlatdar, Silvasa to explain the status of the case. The Mamlatdar endorsed the facts submitted by Residence Deputy Collector(s), Silvasa and requested the Commission for granting six months' time for scrutiny.

After discussion, Hon'ble Member agreed with the suggestions of Mamlatdar, Silvasa and granted three months' time to the District Administration of Dadra & Nagar Haveli, Silvasa for re-examination of the case.
