Minutes of sitting held in the NCST's Headquarters on 28/08/2018 at 1:00 P.M. onwards under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Ramanbhai Gadabhai Patel, R/o Gandhigram - Aamali, Silvaasa, Dadra & Nagar Haveli regarding grabbing of land by Ms. Gulbiben Shankerbhai Patel by making the false documents.

Representation dated nil received from Shri Ramanbhai Gandabhai Patel, R/o Gandhigram - Aamali, Silvaasa, Dadra & Nagar Haveli regarding grabbing of land by Ms. Gulbiben Shankerbhai Patel by making the false documents. Representation was referred to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments within 30 days from receipt of the letter dated 11/04/2018. Response was not received.

Shri H. C. Vasava, Hon'ble Member discussed the issue with the Mamlatdar, Silvasa in a sitting held on 24/05/2018 wherein petitioner was not present. In the sitting dated 24/05/2018, the Commission recommended that a ccpy of the "Gift Deed" should be sent to the NCST within a month from the receipt of the proceedings of the sitting. Petitioner vide letter dated 07/06/2018 had furnished the supporting documents (in Gujarati language) in the case and requested for justice. In response to Commission's recommendation, the Residence, Deputy Collector(s) Dadra & Nagar Haveli vide letter No. RD/NCST/RGP/2018/2834 dated 17/07/2018 had provided a copy of the registered Gift Deed No. 133 dated 15/06/1987 in the matter.

The Hon'ble Member fixed the sitting for 28/08/2018 to discuss the matter with the Administrator of Dadra & Nagar Haveli and Collector, Dadra & Nagar Haveli, Silvasa. The Collector deputed Mamlatdar, Silvasa to attend the sixting. In the sitting, petitioner stated that the signature of his father in Gift Deed is dummy and not the real. The Hon'ble Member asked the Mamlatdar explained the facts. Mamlatdar explained that the photocopy of Gift Deed provided to the Commission is the real.

After detailed discussion, the Hon'ble Member suggested / recommended that the case should be re-examined by the District Administration and submit the report to the NCST within one month from the receipt of the minutes of the sitting.
