PROCEEDINGS OF SITTING HELD ON 17.07.2018 AT 02.00 P.M CHAIRED BY SMT. MAYA CHINTAMN IVNATE, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SMT. M. ROOPA, SENIOR LECTURER IN MECHANICAL DEPTT. GOVERNMENT POLYTECHNIC WOMEN, KAKINADA REGARDING NON IMPLEMENTATION OF ROSTER POINTS RESERVED FOR ST WOMEN IN ANDHRA UNIVERSITY.

Reference to Proceedings of Sitting held on 01.09.2016 in the Commission, compliance report has not been furnished by the Andhra University, Hyderabad to the Commission. Therefore, Hon'ble Member, Smt. Maya Chintamn Ivnate has fixed a Sitting on 17.07.2018 in the Commission. Accordingly, Shri Aditya Nadh Das, Special Chief Secretary, Education Department, Govt. of Andhra Pradesh, Prof. K. Niranjan, Registrar and Prof. K. Venkatasubbaiah, Dean, Andhra University appeared before the Commission on 17.07.2018. Petitioner, Ms. M. Roopa was also present in the Sitting.

- 2. Matter discussed in detail. Petitioner submitted her grievances of denial of appointment to the post of Associate Professor (Mechanical Engineering) in Andhra University against the reservation point of ST women. She further informed the Commission that as per Andhra Pradesh Govt. order, 33% reservation has been prescribed for women in Andhra Pradesh. The University authority did not comply the reservation for women in the appointment of Teaching Cadre Post. No GO was issued by the Government of Andhra Pradesh. The University authority has filled up the posts without application of reservation for ST women.
- 3. The Registrar, Andhra University has submitted that they have followed the Reservation Roster as per the Government of Andhra Pradesh policy. The reservation point No. 92 was meant for ST, general and no reservation point falls for ST women. In addition, no post of Associate Professor, Mechanical Engineering in which the petitioner had applied was available. Hence, the petitioner's claim for non application of reservation for ST women is not justified. However, the Andhra University has also got concurrence from the Tribal Welfare Department, Govt. of Andhra Pradesh on Reservation Rosters for the post of Teaching Cadre Post.
- 4. The Commission observed that the principal responsibility for issuing orders/instructions on the Reservation Rosters or orders on implementation of Reservation Policy in appointments and promotions rest with Social Welfare

Department, Govt. of Andhra Pradesh. In instant case, no GO was issued from the Social Welfare Department/Govt. of Andhra Pradesh on the preparation of the Reservation Rosters after inclusion of Reservation for women. Hence, the Commission recommends that the Andhra University should clarification/concurrence on the Reservation Rosters particularly placement of the ST Women to be followed for filling up of Teaching Posts (Associate Professor) from the Social Welfare Department and then examine the case as per the clarification of the Social Welfare Department. The Andhra University should submit an action taken report to this Commission within 30 days. After receipt of the action taken report from the Andhra University, the case will be examined and decided by the Commission and if necessary, a Sitting will be held in the Commission.
