The above issue was discussed by the NCST in its sitting (s) convened on 24.05.2018 and

28.08.2018. After discussions in the sitting held on 28.08.2018, the Hon'ble Member suggested

that the consent of applicants be submitted to the Commission. The present position of appeal

filed before the Hon'ble Collector by the petitioner may also be communicated to the Commission

within a month from the receipt of the minutes of the sitting.

vide NCST letter dated 18.09.2018. The response/ action taken report was not received from these

authorities. Accordingly, Hon'ble Member fixed sitting on 26.10.2018 at 11.45 AM and this

Silvassa and Superintendent of Police, Dadra & Nagar Haveli, Silvassa vide NCST notice dated

15.10.2018.
